Hi John,

See your questions and my responses in pink below:

- 1) The pool code on the Exhibit A shows Wolfbone 98098 where the application shows Pearl Bone Spring East 49690, which one is correct? **Wolfbone 98098 is correct.**
- 2) The well name in Exhibit A shows Mead 32 WFB and the application shows Mead 32 TB, which one is correct? **Mead 32 WFB is correct.**
- 3) And just wanted to clarify that there was no depth severance. **You are correct. There is no depth severance.**

As I recall, the application was prepared using the TB designation, rather than WFB designation, in error. The 7H and 8H (Case No. 20699) are targeting the Wolfbone, which became more apparent through conversations with Paul Kautz, at the district office. We had left off the pool name and pool code on the C-102s for these two wells, because we weren't sure how to designate them, but then Marathon had communications with Paul Kautz which clarified things.

I was reviewing Marathon Oil Permian's application for a compulsory pooling for the Mead 32 WFB State 7H. I had a few questions if you could help clarify the following for me.

- 1) In the original application the C-102 states the pool code being 49690 which corresponds to the Pearl Bone Spring East pool, whereas the Exhibit A shows pool code 98098 Wolfbone.
- 2) Also referring back to the application the well name shown is "Mead 32 TB State 7H" and the Exhibit A shows "Mead 32 WFB State 7H".
- 3) In the Exhibit A it shows Depth Severance = No, I just wanted to verify that there was no depth severance.
