1 HEARING EXAMINER ORTH: Let's move to the next
2 two matters, 21200 and 21201. The applicant is Titus Oil &
3 Gas. These are compulsory pooling cases related to a well
4 called Love Shack.

5 Is there someone from Montgomery & Andrews?

6 MS. SHAHEEN: Good morning, Madam Examiner,
7 Sharon Shaheen on behalf of the applicant, Titus Oil & Gas
8 Production.

9 HEARING EXAMINER ORTH: Let me pause with that
10 and see if there is another appearance.

11 (No response.)

12 HEARING EXAMINER ORTH: No? Please go ahead.
13 Thank you.

14 MS. SHAHEEN: I would like to present both of
15 these applications together by affidavit. We submitted the
16 package on Tuesday, and if you take a look at the table of
17 contents, it lays out the checklist for both applications,
18 copies of the applications for both, and Exhibit A is our
19 landman affidavit, and that's followed by Exhibits A1
20 through A8, which provides all the information, the land
21 information requested by the checklist.

22 Exhibit B is our geologist affidavit, which has a
23 number of geology exhibits attached, Exhibits B1 through
24 B11.

25 And Exhibit D is my affidavit of notice. There

1 was only one party to be force pooled, that's Sharbro
2 Energy. We did also notice the State Land Bureau and all of
3 those folks received notice.

4 We did, out of an abundance of caution, also
5 publish notice, and that was attached behind Exhibit C.

6 Back to the nature of the case. It's compulsory
7 pooling, standard 320 to the W/2 W/2 of Section 17 and 18 in
8 Township 26 South, Range 35 East. The first application,
9 21200, is one Bone Spring well, and the second application
10 is, 21201, is two Wolfcamp wells.

11 And with that, unless anyone has questions, I
12 would ask that the Division admit the exhibit package into
13 the record and take the cases under advisement.

14 HEARING EXAMINER ORTH: All right. Thank you,
15 Ms. Shaheen. The exhibits are admitted. Let me ask Mr.
16 Coss if he has any questions.

17 (Exhibits admitted.)

18 EXAMINER COSS: I do not have any questions at
19 this time. Thank you, Ms. Shaheen.

20 HEARING EXAMINER ORTH: Mr. Cox, do you have any
21 questions of Ms. Shaheen?

22 MR. COX: I have no questions, and thank you, Ms.
23 Shaheen. And on another I appreciate -- my staff has
24 mentioned that all of your applications are usually very
25 accurate and you're very timely with your responses, so we

1 appreciate that.

2 HEARING EXAMINER ORTH: Thank you, Mr. Cox, and
3 thank you, Ms. Shaheen. The packet is accepted and will be
4 taken under advisement.
