**PROCEDURAL MATTERS**

Mewbourne Oil Company ("Mewbourne") has filed a Motion to consolidate the above-referenced pooling Cases filed with the Division and to have them referred the Oil Conservation Commission for hearing on the same date as Commission Case Nos. 21277, 21278, 21279 and 21280, which were filed as *de novo* appeals. In view of the complexity of the Commission Cases, resulting from their differential relationships of various degrees to the pooling Cases, the nature of established rights, interests and jurisdictional matters involved, and the need to consider the Commission's time and judicial resources, we respectfully request from the Division sufficient time to respond to Mewbourne's Motion so that a thorough accounting of the issues can be provided prior to a decision being made. Given that the tentative date for hearing the *de novo* appeals is set for September 17, 2020, we request a week's time to respond to

Mewbourne's Motion, our response to be submitted by Friday, July 24, 2020, providing such time period is acceptable.
