BC Operating's Case No. 21378 (Fadeaway Ridge) is on the upcoming September 24 docket. Colgate has filed competing applications in Case Nos. 21467 and 21468 (Bolander), which are on the October 8 docket. The parties have agreed to participate in a status conference on September 24 in order to set the competing proposals on a special docket.

I'm not sure how this should be addressed in light of the fact that the Colgate cases are not set until the October 8 docket, but it seems to me we could discuss a special docket date on September 24, which would ultimately be set depending on the parties' and Division's schedule, and the new setting to a special docket date could be reported and made of record on October 8. The prehearing order could thereafter be entered in all cases.

Please let all counsel know if we should proceed differently, in light of the two different dockets currently existing for the competing proposals.
