2 HEARING EXAMINER ORTH: Good morning, everyone.  
3 My name is Felicia Orth. I'm a hearing officer appointed  
4 by the Director of the Oil Conservation Division to  
5 conduct hearings this morning under 19-15-4 of the New  
6 Mexico Administrative Code.

7 The docket was published on the Internet.  
8 We have 14 cases, primarily affidavit cases and status  
9 conferences. I'll call them in the order in which they  
10 appear on the docket. The hearing is being recorded and  
11 also transcribed by Mary Macfarlane, whom I see on the  
12 call.

13 As Ms. Salvidrez reminded us, please do  
14 mute yourself if you are not speaking or have not been  
15 called on.

16 Let's see. Marlene, we have some more  
17 folks who need to be made panelists. I have Ms. Shaheen  
18 and Mr. Feldewert.

19 MS. SALVIDREZ: Because you are the host, you  
20 will need to do it. I can't do it right now.

21 HEARING EXAMINER ORTH: All right. Let me do  
22 that right now. Mr. Feldewert and Ms. Shaheen made  
23 panelists. All right.

24 So I've just made Mr. Feldewert and Ms.

3 morning is Kathleen Murphy. The backup technical examiner  
4 is Scott Cox.

5 And, Ms. Murphy, I believe you indicated

7 HEARING EXAMINER MURPHY: I just have a  
8 suggestion for when you send .pdfs into the OCD hearings,  
9 and sometimes you have a number of documents and you put  
10 in the title bar the case file number. Try to make sure  
11 that all the individual documents have a case file number  
12 in their title.

13 And the second announcement I have is today  
14 is, I believe, the last hearing for Marilyn Gruebel. And,  
15 you know, she's had the New Mexico Permian Subscription  
16 Service, and she's discontinuing that, and I would just  
17 like to thank her for all her hard work. The OCD has  
18 utilized her reports for a lot of data entries, and she's  
19 also helped me in a couple of important topics over the  
20 last two years that I have been here.

21 So thank you, Marilyn.

22 HEARING EXAMINER ORTH: Let me echo that.  
23 Marilyn has been a gracious presence at all of the  
24 hearings I've done since January, first obviously in  
25 person, and then electronically. And helpful to me when I

1 was struggling with some Webex matter two weeks ago.

2 So thank you, Marilyn. We'll miss you.

3 All right. Is there anything else before we  
4 begin with the cases? No?
