Page 3 1 HEARING EXAMINER ORTH: Let's move then to matter 2 21488. The applicant is Spur Energy Partners, compulsory pooling application. The well name is Poseidon. 3 Ms. Hardy, are you here again for this applicant? 4 5 MS. HARDY: Yes, I am. Dana Hardy on behalf of Spur Energy Partners. 6 7 HEARING EXAMINER ORTH: Thank you. I saw an 8 entry of appearance for ConocoPhillips. Who here is from 9 Holland & Hart? 10 MR. FELDEWERT: May it please the Examiner, Michael Feldewert with the Santa Fe office of Holland & 11 12 Hart --13 (Audio interference.) 14 HEARING EXAMINER ORTH: Mr. Feldewert? Mr. 15 Feldewert, I'm sorry to interrupt you, it says you have low band width. You might want to turn off your video. We 16 17 really didn't hear anything you said. 18 MR. FELDEWERT: Now (inaudible) me. HEARING EXAMINER ORTH: I only heard the words 19 20 now and me. 21 MR. FELDEWERT: Let me do some adjustment. 22 HEARING EXAMINER ORTH: We'll wait a moment. 23 MR. FELDEWERT: Okay. Can you hear me better 24 now? 25 HEARING EXAMINER ORTH: Yes. I heard all of

Page 4 1 that. MR. FELDEWERT: Thank you. Thank you. Sorry 2 about that. I apologize. 3 4 HEARING EXAMINER ORTH: That's all right. Let's start over. Mr. Feldewert, are you here for ConocoPhillips? 5 MR. FELDEWERT: I am, and ConocoPhillips does not 6 7 object to the matter proceeding by affidavit. 8 HEARING EXAMINER ORTH: Oh, thank you very much. 9 Let me pause a moment in the event there are other 10 appearances this morning. 11 (No audible response.) 12 HEARING EXAMINER ORTH: I hear nothing. Ms. 13 Hardy, if you would, please, go ahead. 14 MS. HARDY: Thank you. In this case Spur seeks 15 an order pooling all uncommitted mineral interests in the Yaso Formation in a 320 acre standard proximity tract 16 17 horizontal spacing unit comprised of the S/2 of Section 3, Township 17 South, Range 30 East in Eddy County. 18 In support of the application we have provided 19 the self-affirmed statement of landman Morgan Landry, as 20 well as the self-affirmed statement of geologist CJ 21 Lipinski. 22 Mr. Landry's self-affirmed statement provides all 23 24 of the standard land exhibits. He identifies the ownership 25 interest in each tract, provides a plot of the tracts and

Page 5 identifies the pooled party in Exhibit A-4 to his self-1 2 affirmed statement. I will note that Mr. Landry has not previously testified, and so we have provided his statement 3 4 of qualifications along with his affidavit. 5 We did provide proposed notice of the hearing 6 more than 20 days in advance by certified mail and also published notice out of an abundance of caution. There are 7 8 no unlocatable interests. In fact, the only party that Spur seeks to pool is ConocoPhillips in this case. 9 10 Mr. Lipinski has provided the geology exhibits including a location map, the gunbarrel schematic, a 11 12 structure map, an isochore map and a cross section. 13 So with that, unless there are questions, I would 14 ask that the exhibits be accepted into the record and that the case be taken under advisement. And I would also ask 15 Mr. Landry be qualified as an expert in petroleum land 16 17 matters. Thank you. 18 HEARING EXAMINER ORTH: All right. Thank you, Ms. Hardy. Mr. Feldewert, do you have any questions? 19 MR. FELDEWERT: I do not, and, Madam Examiner, if 20 I may, I'm going to start my video and test it here. 21 22 HEARING EXAMINER ORTH: All right. 23 MR. FELDEWERT: Are you still -- can you still 24 hear with my video on? 25 HEARING EXAMINER ORTH: Your sound quality

Ms. 13 Hardy, your exhibits are accepted, Mr. Landry is qualified 14 as an expert, and the matter will be taken under advisement. MS. HARDY: Thank you very much. 15 16 (Exhibits admitted.)
