Marathon Oil Permian, LLC ("Marathon") respectfully requests a one (1) year extension to complete the wells under Order No. R-20306 (the "Order"). This extension is being requested because there have been changes in Marathon's drilling schedule due to COVID-19 and current market conditions. The wells and lands impacted by this extension are the following:

WELLS:

Charlie Murphy 6 WXY FC Well No. 12H, API No. 30-

025-46486

Charlie Murphy 6 WXY FC Well No. 18H, API 30-025-

64687

LANDS:

640-acre (more or less) spacing unit underlying the E/2 of Section 6 and the E/2 of Section 7, Township 26 South, Range 35 East, NMPM, Lea County, New

Mexico.

The Order was issued on September 20, 2018, and requires Marathon to commence completion operations within one year after commencement of drilling operations. Order, p. 5, ¶ 9. Marathon timely commenced drilling operations for Wells 12H and 18H but requires additional time to commence completion operations for those wells. Marathon spud the Charlie Murphy 6

PO Box 2168 Albuquerque, New Mexico 87103 WXY FC Well No. 12H on December 13, 2019, and spud the Charlie Murphy 6 WXY FC Well No. 18H on December 20, 2019. *See* Gyllenband Self-Affirmed Statement, attached as Exhibit A to this request. Marathon asks that the deadline to complete Wells Nos. 12H and 18H be extended to December 20, 2021, which is one year from the date Marathon spud the Charlie Murphy 6 WXY FC Well No. 18H well, so that the deadline for completion for both wells is the same date. Alternatively, Marathon requests that the deadline to complete Charlie Murphy 6 WXY FC Well No. 12H be extended to December 13, 2021, and the deadline to complete the Charlie Murphy 6 WXY FC Well No. 18H be extended to December 20, 2021.

The Order states Marathon may request a written extension of time from the Division Director "pursuant to a written request stating its reasons for such extension and attaching satisfactory evidence." See Order, p. 5, ¶ 9. The Order also states that Marathon "shall provide a copy of any request for extension of time to drill or complete any well filed with the Director pursuant to this order to each pooled working interest owner who has elected to participate in the drilling of any well that is the subject of the request." See Order, p. 5, ¶ 10. Marathon attaches an affidavit of a Land Professional confirming that Chevron U.S.A., Inc. is the only party entitled to notice under this requirement, and that Marathon's extension request is made in good faith and warranted. See Gyllenband Self-Affirmed Statement, attached as Exhibit A to this request.

- 2. I submit the following information in support of receiving extensions for the above referenced compulsory pooling order.
- 3. My area of responsibility at Marathon includes the area of Lea County in New Mexico.
  - 4. I am familiar with the order the Division issued in the above captioned case.
- 5. I am familiar with the status of the lands that are subject to the compulsory pooling order and with the status of Marathon's operations on the spacing unit approved by the order.
  - 6. I have reviewed the compulsory pooling order in the above captioned case.
- 7. I have reviewed Marathon's records regarding each of the Charlie Murphy wells that are the subject of this extension request.
- 8. The spud date for the Charlie Murphy 6 WXY FC Well No. 12H ("Well No. 12H") was December 13, 2019, and the spud date for the Charlie Murphy 6 WXY FC Well No. 18H ("Well No. 18H") was December 20, 2019.



9. Marathon timely spud Well No. 12H and Well No. 18H but is requesting additional

time to complete the wells.

10. Due to the recent COVID-19 pandemic and downturn in the oil and gas market,

Marathon is not able to complete those wells within the timeline outlined in the order.

11. Order R-20306 requires Marathon to provide notice to pooled working interest

owners that have elected into the wells that are the subject of this extension request. Chevron

U.S.A., Inc. is the only pooled working interest owner that has elected to participate in Well No.

12H and Well No. 18H and is the only party entitled to notice of a request for extension under

Order R-20306.

12. It is my opinion that the granting of this extension is reasonable and in the interests

of conservation and the prevention of waste.
