**APPLICATION**

SPC Resources, LLC (“Applicant”) (OGRID No. 372262), through its undersigned attorneys, hereby files this application with the Oil Conservation Division, to amend Order No. R-21096: (1) to pool additional interest owners under the terms of Order No. R-21096; (2) to allow for an extension of time for drilling a well under Order No. R-21096; (3) to update the names and locations (if necessary) of the Proposed Wells, and (4) to conform Order No. R-21096 to the amended order template (“Amended Order”) described in the Division Director’s April 9, 2020 *Letter to Counsel Regarding Amended CP Order Template*. In support of its application, Applicant states:

1. Division Order No. R-21096, entered on February 12, 2020 in Case No. 20762, created a 1,267.1-acre, more or less, standard horizontal spacing unit consisting of the W/2 and E/2 of Section 12, Township 22 South, Range 26 East, and the W/2 and E/2 of Section 7, Township 22 South, Range 27 East, NMPM, Eddy County, New Mexico (the “Unit”), and designated Applicant as the operator of the Unit.

2. Order No. R-21096 further pooled the uncommitted interests in the Wolfcamp formation (Purple Sage; Wolfcamp Pool (Pool Code 98220)) in the Unit and dedicated the Unit to the following Proposed Wells: (1) the **Caveman 7-12 WCXY #2H well**; and (2) the **Caveman 7-12 WCD #3H well**.

3. Since the entry of Order No. R-21096, Applicant has changed the names of the Proposed wells as follows: the **Caveman 7-12 WCXY #2H well** is now the **Caveman 402H well**, and the **Caveman 7-12 WCD #3H well** is now the **Caveman 443H well**. Santo may update the locations of the Proposed Wells which will be presented at the hearing in this case.

4. Further, Applicant seeks to pool additional interest owners in the Unit under the terms of Order No. R-21096. The pooling of the additional interest owners under the terms of the Order will prevent waste, will protect correlative rights, and will promote administrative efficiency. In order to permit Applicant to obtain its just and fair share of the oil and gas underlying the subject lands, the additional interest owners should be pooled in the Unit pursuant to the terms of Order No. R-21096.

5. Applicant requests that Order No. R-21096 be re-opened and amended to allow Applicant additional time to commence drilling a well under the Order. There is good cause for Applicant's request for an extension of time due to the unfavorable economic environment, the global pandemic caused by COVID and reduction in rig count, and Applicant has delayed its intended plans to develop the acreage subject to the Order. Under the Order, Applicant would be required to commence drilling a well by February 12, 2021; and therefore asks for the deadline to commence drilling a well be extended for a year, to February 12, 2022.

6. Finally, Applicant requests that Order No. R-21096 be re-issued to conform this order to the terms of the Amended Order.

WHEREFORE, Applicant requests that this application be set for hearing before an Examiner of the Oil Conservation Division on January 7, 2021, and after notice and hearing as required by law, the Division pool the additional interest owners pursuant to the terms of Order No. R-21096; amend Order No. R-21096 to extend the time for SPC Resources LLC to commence

drilling a well under the Order for a year, through February 12, 2022; update the names and locations (if necessary) of the Proposed Wells; and amend Order No. R-21096 to conform to the terms of the Amended Order.

**AFFIDAVIT OF COLLEEN BRADLEY  
IN SUPPORT OF CASE NO. 21577**

Colleen Bradley, of lawful age and being first duly sworn, declares as follows:

1. My name is Colleen Bradley. I work for Santo Petroleum LLC, an affiliate of SPC Resources, LLC (“SPC”), as a Landman.
2. I have previously testified before the New Mexico Oil Conservation Division as an expert witness in petroleum land matters. My credentials as a petroleum landman have been accepted by the Division and made a matter of record.
3. I am familiar with the application filed by SPC in this case, and I am familiar with the status of the lands in the subject area.
4. I do not anticipate any opposition to this case or the presentation of the case by affidavit.
5. Division Order No. R-21096, entered on February 12, 2020 in Case No. 20762, created a 1,267.10-acre, more or less, standard horizontal spacing unit consisting of the W/2 and E/2 of Section 12, Township 22 South, Range 26 East, and the W/2 and E/2 of irregular Section 7, Township 22 South, Range 27 East, NMPM, Eddy County, New Mexico (the “Unit”), and designated SPC Resources as the operator of the Unit.
6. Order No. R-21096 further pooled the uncommitted interests in the Wolfcamp formation (Purple Sage; Wolfcamp Pool (Pool Code 98220)) in the Unit and dedicated the Unit to

the following Proposed Wells: (1) the Caveman 7-12 WCXY #2H well; and (2) the Caveman 7-12 WCD #3H well.

7. A true and correct copy of Division Order No. R-21096 is attached hereto as **SPC Exhibit B-1**.

8. Since the entry of Order No. R-21096, SPC Resources has determined it is necessary to amend Order No. R-21096: (1) to pool additional interest owners under the terms of Order No. R-21096; (2) to allow for an extension of time for drilling a well under Order No. R-21096; (3) to update the names and locations of the Proposed Wells, and (4) to conform Order No. R-21096 to the amended order template ("*Amended Order*") described in the Division Director's April 9, 2020 *Letter to Counsel Regarding Amended CP Order Template*.

9. Since the entry of Order No. R-21096, SPC has discovered additional interest owners in the Unit that need to be pooled under the terms of the Order. **SPC Exhibit B-2** is a unit recap and map reflecting that SPC seeks to pool all interest owners in unleased tracts (as indicated in blue on the map, Exhibit B-2), the lands within Santo leases (as indicated in yellow on the map, Exhibit B-2), and any non-participating or unlocatable working interest owners that were also provided notice of this hearing as reflected on Exhibits C and D. SPC respectfully requests that these additional interest owners be pooled pursuant to the terms of the Order No. R-21096.

10. **SPC Exhibit B-3** are copies of the first page of the Form C-102s for each of the wells in the spacing unit in this case. Since the entry of Order No. R-21096, SPC Resources has changed the names and locations of the Proposed Wells as follows: the Caveman 7-12 WCXY #2H well is now the **Caveman 402H Well**, and the Caveman 7-12 WCD #3H well is now the **Caveman 442H Well**, to be drilled from surface hole locations in the SW/4 NW/4 (Unit E) of

Section 8, Township 22 South, Range 27 East, to bottom hole locations in the SW/4 NW/4 (Unit E) of Section 12, Township 22 South, Range 26 East.

11. SPC Resources requests that Order No. R-21096 be re-opened and amended to allow SPC Resources additional time to commence drilling a well under the Order. There is good cause for SPC Resources' request for an extension of time due to the unfavorable economic environment, the global pandemic caused by COVID and reduction in rig count, and SPC Resources has delayed its intended plans to develop the acreage subject to the Order. SPC Resources requests a one-year extension of the deadline to commence drilling to February 12, 2022.

12. Finally, SPC Resources requests that any order entered in this case includes provisions conforming Order No. R-21096 to the *Amended Order*.

13. **SPC Exhibit B-4** identifies the names and addresses of each interest owner to be pooled. **SPC Exhibit B-4** also provides the tracking information for the letters providing notice of this hearing to the additional interest owners to be pooled.

14. **SPC Exhibit B-5** is a copy of the letter providing notice of this hearing that SPC sent by certified mail to each of the interest owners to be pooled.

15. **SPC Exhibits B-1 through B-5** were either prepared by me or compiled under my direction and supervision.

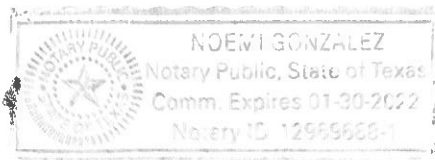

**ORDER**

The Director of the New Mexico Oil Conservation Division (“OCD”), having heard this matter through a Hearing Examiner on September 19, 2019, and after considering the testimony, evidence, and recommendation of the Hearing Examiner, issues the following Order.

**FINDINGS OF FACT**

1. SPC Resources, LLC (“Operator”) submitted an application (“Application”) to compulsory pool the uncommitted oil and gas interests within the spacing unit (“Unit”) described in Exhibit A. The Unit is expected to be a standard horizontal spacing unit. 19.15.16.15(B) NMAC. Operator seeks to be designated the operator of the Unit.
2. Operator will dedicate the well(s) described in Exhibit A (“Well(s)”) to the Unit.
3. Operator proposes the supervision and risk charges for the Well(s) described in Exhibit A.
4. Operator identified the owners of uncommitted interests in oil and gas minerals in the Unit and provided evidence that notice was given.
5. The Application was heard by the Hearing Examiner on the date specified above, during which Operator presented evidence through affidavits in support of the Application. No other party presented evidence at the hearing.

### CONCLUSIONS OF LAW

6. OCD has jurisdiction to issue this Order pursuant to NMSA 1978, Section 70-2-17.
7. Operator is the owner of an oil and gas working interest within the Unit.
8. Operator satisfied the notice requirements for the Application and the hearing as required by 19.15.4.12 NMAC.
9. OCD satisfied the notice requirements for the hearing as required by 19.15.4.9 NMAC.
10. Operator has the right to drill the Well(s) to a common source of supply at the described depth(s) and location(s) in the Unit.
11. The Unit contains separately owned uncommitted interests in oil and gas minerals.
12. Some of the owners of the uncommitted interests have not agreed to commit their interests to the Unit.
13. The pooling of uncommitted interests in the Unit will prevent waste and protect correlative rights, including the drilling of unnecessary wells.
14. This Order affords to the owner of an uncommitted interest the opportunity to produce his just and equitable share of the oil or gas in the pool.

### ORDER

15. The uncommitted interests in the Unit are pooled as set forth in Exhibit A.
16. The Unit shall be dedicated to the Well(s) set forth in Exhibit A.
17. Operator is designated as operator of the Unit and the Well(s).
18. If the Surface Location or Bottom Hole Location of a well is changed from the location described in Exhibit A, Operator shall submit an amended Exhibit A, which the Division shall append to this Order.
19. If the location of a well will be unorthodox under the spacing rules in effect at the time of completion, Operator shall obtain the OCD's approval for a non-standard location before commencing production of the well.
20. The Operator shall commence drilling the initial well within one (1) year after the date of this Order; and (b) for an infill well, no later than thirty (30) days after completion of the well.

21. Operator shall comply with the infill well requirements in 19.15.13.9 NMAC through 19.15.13.12 NMAC.
22. This Order shall terminate automatically if Operator fails to comply with Paragraphs 20 or 21.
23. Operator shall submit to OCD and each owner of a working interest in the pool ("Pooled Working Interest") an itemized schedule of estimated costs to drill, complete, and equip the well ("Estimated Well Costs") no later than: (a) for an initial well, no later than thirty (30) days after the date of this Order; (b) for an infill well proposed by Operator, no later than (30) days after the later of the initial notice period pursuant to 19.15.13.10(B) NMAC or the extension granted by the OCD Director pursuant 19.15.13.10(D) NMAC; or (c) for an infill well proposed by an owner of a Pooled Working Interest, no later than thirty (30) days after expiration of the last action required by 19.15.13.11 NMAC.
24. No later than thirty (30) days after Operator submits the Estimated Well Costs, the owner of a Pooled Working Interest shall elect whether to pay its share of the Estimated Well Costs or its share of the actual costs to drill, complete and equip the well ("Actual Well Costs") out of production from the well. An owner of a Pooled Working Interest who elects to pay its share of the Estimated Well Costs shall render payment to Operator no later than thirty (30) days after the expiration of the election period, and shall be liable for operating costs, but not risk charges, for the well. An owner of a Pooled Working Interest who fails to pay its share of the Estimated Well Costs or who elects to pay its share of the Actual Well Costs out of production from the well shall be considered to be a "Non-Consenting Pooled Working Interest."
25. No later than within one hundred eighty (180) days after Operator submits a Form C-105 for a well, Operator shall submit to OCD and each owner of a Pooled Working Interest an itemized schedule of the Actual Well Costs. The Actual Well Costs shall be considered to be the Reasonable Well Costs unless OCD or an owner of a Pooled Working Interest files a written objection no later than forty-five (45) days after receipt of the schedule. If OCD or an owner of a Pooled Working Interest files a timely written objection, OCD shall determine the Reasonable Well Costs after public notice and hearing.
26. No later than sixty (60) days after the later of the expiration of the period to file a written objection to the Actual Well Costs or OCD's order determining the Reasonable Well Costs, each owner of a Pooled Working Interest who paid its share of the Estimated Well Costs shall pay to Operator its share of the Reasonable Well Costs that exceed the Estimated Well Costs, or Operator shall pay to each owner of a Pooled Working Interest who paid its share of the Estimated Well Costs its share of the Estimated Well Costs that exceed the Reasonable Well Costs.

27. The reasonable charges for supervision to drill and produce a well ("Supervision Charges") shall not exceed the rates specified in Exhibit A, provided however that the rates shall be adjusted annually pursuant to the COPAS form entitled "Accounting Procedure-Joint Operations."
28. No later than within ninety (90) days after Operator submits a Form C-105 for a well, Operator shall submit to OCD and each owner of a Pooled Working Interest an itemized schedule of the reasonable charges for operating and maintaining the well ("Operating Charges"), provided however that Operating Charges shall not include the Reasonable Well Costs or Supervision Charges. The Operating Charges shall be considered final unless OCD or an owner of a Pooled Working Interest files a written objection no later than forty-five (45) days after receipt of the schedule. If OCD or an owner of a Pooled Working Interest files a timely written objection, OCD shall determine the Operating Charges after public notice and hearing.
29. Operator may withhold the following costs and charges from the share of production due to each owner of a Pooled Working Interest who paid its share of the Estimated Well Costs: (a) the proportionate share of the Supervision Charges; and (b) the proportionate share of the Operating Charges.
30. Operator may withhold the following costs and charges from the share of production due to each owner of a Non-Consenting Pooled Working Interest: (a) the proportionate share of the Reasonable Well Costs; (b) the proportionate share of the Supervision and Operating Charges; and (c) the percentage of the Reasonable Well Costs specified as the charge for risk described in Exhibit A.
31. Each year on the anniversary of this Order, and no later than ninety (90) days after each payout, Operator shall provide to OCD and each owner of a Non-Consenting Pooled Working Interest a schedule of the revenue attributable to a well and the Supervision and Operating Costs charged against that revenue.
32. Any cost or charge that is paid out of production shall be withheld only from the share due to an owner of a Pooled Working Interest. No cost or charge shall be withheld from the share due to an owner of a royalty interests. For the purpose of this Order, an unleased mineral interest shall consist of a seven-eighths (7/8) working interest and a one-eighth (1/8) royalty interest.
33. Except as provided above, Operator shall hold the revenue attributable to a well that is not disbursed for any reason for the account of the person(s) entitled to the revenue as provided in the Oil and Gas Proceeds Payment Act, NMSA 1978, Sections 70-10-1 *et seq.*, and relinquish such revenue as provided in the Uniform Unclaimed Property Act, NMSA 1978, Sections 7-8A-1 *et seq.*

34. The Unit shall terminate if (a) the owners of all Pooled Working Interests reach a voluntary agreement; or (b) the well(s) drilled on the Unit are plugged and abandoned in accordance with the applicable rules. Operator shall inform OCD no later than thirty (30) days after such occurrence.
35. OCD retains jurisdiction of this matter for the entry of such orders as may be deemed necessary.

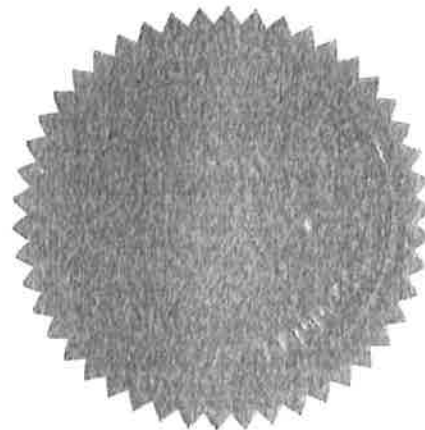

SPC Resources, LLC (“Applicant”) (OGRID No. 372262), through its undersigned attorneys, hereby files this application with the Oil Conservation Division, to amend Order No. R-21096: (1) to pool additional interest owners under the terms of Order No. R-21096; (2) to allow for an extension of time for drilling a well under Order No. R-21096; (3) to update the names and locations (if necessary) of the Proposed Wells, and (4) to conform Order No. R-21096 to the amended order template (“Amended Order”) described in the Division Director’s April 9, 2020 *Letter to Counsel Regarding Amended CP Order Template*. In support of its application, Applicant states:

1. Division Order No. R-21096, entered on February 12, 2020 in Case No. 20762, created a 1,267.1-acre, more or less, standard horizontal spacing unit consisting of the W/2 and E/2 of Section 12, Township 22 South, Range 26 East, and the W/2 and E/2 of Section 7, Township 22 South, Range 27 East, NMPM, Eddy County, New Mexico (the “Unit”), and designated Applicant as the operator of the Unit.

2. Order No. R-21096 further pooled the uncommitted interests in the Wolfcamp formation (Purple Sage; Wolfcamp Pool (Pool Code 98220)) in the Unit and dedicated the Unit to the following Proposed Wells: (1) the **Caveman 7-12 WCXY #2H well**; and (2) the **Caveman 7-12 WCD #3H well**.



3. Since the entry of Order No. R-21096, Applicant has changed the names of the Proposed wells as follows: the **Caveman 7-12 WCXY #2H well** is now the **Caveman 402H well**, and the **Caveman 7-12 WCD #3H well** is now the **Caveman 443H well**. Santo may update the locations of the Proposed Wells which will be presented at the hearing in this case.

4. Further, Applicant seeks to pool additional interest owners in the Unit under the terms of Order No. R-21096. The pooling of the additional interest owners under the terms of the Order will prevent waste, will protect correlative rights, and will promote administrative efficiency. In order to permit Applicant to obtain its just and fair share of the oil and gas underlying the subject lands, the additional interest owners should be pooled in the Unit pursuant to the terms of Order No. R-21096.

5. Applicant requests that Order No. R-21096 be re-opened and amended to allow Applicant additional time to commence drilling a well under the Order. There is good cause for Applicant's request for an extension of time due to the unfavorable economic environment, the global pandemic caused by COVID and reduction in rig count, and Applicant has delayed its intended plans to develop the acreage subject to the Order. Under the Order, Applicant would be required to commence drilling a well by February 12, 2021; and therefore asks for the deadline to commence drilling a well be extended for a year, to February 12, 2022.

6. Finally, Applicant requests that Order No. R-21096 be re-issued to conform this order to the terms of the Amended Order.

WHEREFORE, Applicant requests that this application be set for hearing before an Examiner of the Oil Conservation Division on January 7, 2021, and after notice and hearing as required by law, the Division pool the additional interest owners pursuant to the terms of Order No. R-21096; amend Order No. R-21096 to extend the time for SPC Resources LLC to commence

drilling a well under the Order for a year, through February 12, 2022; update the names and locations (if necessary) of the Proposed Wells; and amend Order No. R-21096 to conform to the terms of the Amended Order.
