Spur seeks an order pooling additional interest owners under the terms of Order No. R-21622. Division Order No. R-21622, entered on March 15, 2021, in Case No. 21675, created a standard 320-acre horizontal spacing unit in the Yeso formation comprised of the S/2 of Section 12, Township 19 South, Range 25 East, NMPM, Eddy County, New Mexico. The Order

dedicated the above-referenced horizontal spacing unit to the following proposed initial wells: (1) the Rose South #10H well, (2) the Rose South #50H well, (3) the Rose South #60H well, (4) the Rose South #11H well, (5) the Rose South #51H well, and (6) the Rose South #20H well.
