3 director of the Oil Conservation Division to conduct
4 adjudicatory hearings today on July 23, 2020 at 8:15. The
5 OCD hearings docket for today's session can be found on the
6 Division's web page.

7 You will see we have 14 matters, several of which
8 are consolidated with other matters, some of which will
9 proceed by affidavit, and some of which I have status
10 conferences.

11 In the event this hearing session is disrupted by

14 session. The technical examiner who will be posing any
