Dear Commissioner or to whom it may concern,

I received certified mail on July 29, 2022, notifying me that Matador Production Company filed an application with the New Mexico Oil Conservation Division to force pooling of my mineral rights. A hearing is scheduled on August 18, 2022. I am unable to attend this hearing due to work commitments (I cannot attend either in person or virtually).

I respectfully request a 30-day extension to hire someone to investigate his matter and advise me on my rights in these cases and the consequences of the forced pooling action.
