1 HEARING EXAMINER BRANCARD: Okay. All right. So
2 let's try to get these last two cases in here. We are on
3 Items 52 through 55, and we may have already resolved these,
4 cases 22633, 22634, 22635, 22636, Mewbourne Oil Company.

5 MR. BRUCE: Mr. Examiner, Jim Bruce representing
6 Mewbourne Oil Company.

7 HEARING EXAMINER BRANCARD: Thank you. These
8 were part of a competing application which may no longer be
9 competing, but we have an entry from COG Operating.

10 MR. RANKIN: Adam Rankin, with the Santa Fe
11 office of Holland & Hart appearing on behalf of COG
12 Operating LLC in these cases.

13 HEARING EXAMINER BRANCARD: BTA Oil Producers?

14 MR. BRUCE: Mr. Examiner, Jim Bruce entering an
15 appearance for BTA. When the cases were contested, BTA was
16 supporting Mewborne, but even though the contested cases are
17 gone, I'm still entering an appearance for BTA.

18 HEARING EXAMINER BRANCARD: Yes, you did a very
19 unusual maneuver, entering an appearance for one party
20 within the pleading you submitted for a different party.

21 MR. BRUCE: I did that simply so I didn't have to
22 file four documents -- eight documents with the OCD rather
23 than four documents.

24 HEARING EXAMINER BRANCARD: Okay. Are there any
25 other interested persons for cases 22633, 634, 635, 636.

HEARING EXAMINER BRANCARD: Hearing none, Mr. Bruce, so I raised a notice issue earlier today about the -- what appear to be unlocatable parties that COG had located in another case located just north.

MR. BRUCE: Mr. Examiner, if I may start off, three resolvable issues. One is the notice that you just mentioned, and I will -- the cases will have to be continued so I can give notice to the new addresses and also advise my client to try to get ahold of the people to settle the matter with them.

Number 2, I received the publication affidavit from the Hobbs newspaper on Tuesday, and I had it in my clammy little meat hooks and it vanished somehow. I did submit in the exhibit packages the original notice from the newspaper when they agreed to publish it, but nonetheless I'm hoping to find that original affidavit.

And then Number 3, even though I got that proposed notice to the newspaper on the same date as I did those previous Matador cases that we presented earlier, the notice was not published until a day after the publication deadline.

And so it's up to you. I can present them and then continue them, or I can continue them, and since they are not opposed, I would ask that they be continued to

1 September 1. Whether you want me to present them now or
2 make the day shorter and just continue them so I can take
3 care of the (unclear audio) of this case, it's totally up to
4 you.

5 HEARING EXAMINER BRANCARD: Thank you. So
6 September 1 will be enough time for you to --

7 MR. BRUCE: Yeah, that's more than 20 days so I
8 can get certified notice out to the two locatable parties,
9 and hopefully I can dig up and cure the publication date and
10 hopefully I can find that publication affidavit somewhere
11 along the way.

12 HEARING EXAMINER BRANCARD: Okay. Well, why
13 don't we just continue these case to the September 1.

14 MR. BRUCE: Okay.

15 HEARING EXAMINER BRANCARD: Clean up the record.

16 MR. BRUCE: Yes. And one final thing, Mr.
17 Examiner, if I could directly address Mr. Baca for just a
18 few seconds.

19 HEARING EXAMINER BRANCARD: Sure. I don't think
20 he can talk to you, but he can maybe wave at you.

21 MR. BRUCE: It's just a personal message. First
22 of all, Paul, I hope you are doing well, and I wanted you to
23 know that just a few minutes ago a certain Mr. James
24 Sullivan walked into my office, I won't put him on the
25 phone, but he said to say hi. So Jamie says hi to you as

1 well I do. Thank you.

2 HEARING EXAMINER BRANCARD: Thank you. All
3 right. So with that, cases 22633, 22634, 22635, 22636 will
4 be continued to September 1.

5 MR. BRUCE: Thank you, Mr. Examiner.
