We believe that Alpha Energy Partners LLC filed the compulsory pooling application against our property in Eddy County, New Mexico under false pretenses by stating that they were not able to get in touch with us, the property owners.

However, we have repeatedly emailed and been in contact with Alpha Energy Partners LLC.

Also, we object to Alpha Energy Partners LLC trying to extend a three-year Lease into a five-year Lease.

We have dealt with John Coffman who is the contact representative for Alpha Energy Partners LLC. We advised him by email and also called Mr. John Coffman to tell him that we knew that he needed to send us the oil gas mineral Lease in Mrs. Lillie Anderson's name and he advised us that he would.

Nonetheless, we received a compulsory pooling application file from Alpha Energy Partners LLC that was against our property in Eddy County, New Mexico.

We also told Permian Asset Co. LLC the same exact thing.

Permian Asset Co. LLC did eventually forward the oil gas

mineral Lease in the right name, back in August or September.

Nonetheless, we added adjustments to the oil gas mineral Lease, under the terms that Mrs. Anderson and I believe are reasonable, and sent it back to Alpha Energy Partners LLC and Permian Asset Co. LLC. However, we never heard back from Alpha Energy Partners LLC and Permian Asset Co. LLC.

Later, we were contacted by John Coffman, who sent a Lease with the same terms, but the Lease was once again in my father's name, who is deceased.

Afterwards, we received said compulsory pooling application against the land in Eddy County, New Mexico. It appears that the Lease had taken on a harrassing tone.

We believe the statements made about the attached oil gas mineral Lease, see Exhibit A, the first oil gas mineral Lease sent by Alpha Energy Partners LLC and Permian Asset Co. LLC. See Exhibit B, the second oil gas mineral Lease, that was sent back with adjustments.
