That order should have instructed the operator to file form C-102 to indicate where the well is producing from after abolishing the previous pool.

On a related matter, I am drafting an order in which five pools will be abolished and consolidated into one pool as follows:

Pools to be abolished are: (1) The Cedar Lake Glorieta-Yeso Pool(96831),(2). The Fren-Glorieta Yeso Pool(26770), (3). The East Fren-Glorieta Yeso Pool (97213), {4}. The Loco Hills Glorieta Yeso Pool (96718), and (5). The West Maljamar Yeso Pool (44500).

These pool will be consolidated into one pool called the Mar Loco Glorieta-Yeso Pool consisting of the horizontal limits of these five pools. Please assign a pool code to this consolidated pool for my use in drafting the order. Thank you

The order abolishing the Cemetary;Yeso pool did not contain the standard clause in it. Santa Fe in the past, in the orders abolishing a pool gave present operators in the pool 30 days to file with the appropriate district office new C-102's for the new pool. Since Santa Fe left this clause out, the operators do not know that they are suppose to file new C-102's. Until the operator files new C-102's the district (in this case the Artesia District office) cannot change the pool.
