David: I sent the BLM and OCD-Artesia the application and C-108 on 10/7 by certified mail, and then received an updated C-108 from the client and sent that to the same offices last week so they would have all pertinent data.

I'd note that Wesley requested the data, and I sent it to him, but the BLM is not one of the parties Lime Rock is required to give notice to (it is not a surface owner where the injection wells are located, and the offset operators or WIO's of federal leases were properly notified).

I want to put the case on this week, but I have no problem with the BLM filing a letter entry of appearance to preserve its rights.
