1           EXAMINER EZEANYIM: This hearing will come to order.  
 2    Good morning, everybody. Today is Thursday, October 27, at  
 3    approximately 8:15 in the morning, and today we are going to  
 4    consider Docket Number 31-11. As you all can see, my legal  
 5    examiner is not here, but I think I can handle it. I don't  
 6    think I will have a lot of contested cases, otherwise the  
 7    application will be overruled because I'm not an attorney.  
 8    But anyway, we are going to have fun and probably get out of  
 9    here at 1 or 1:30.

10           The first order of business today normally is to  
 11    read all the continuances and the dismissals.

 17    November the 10th. Case Number 14747 is continued to  
 18    November the 10th. Case Number 14748 is continued to  
 19    November the 10th. Case Number 14736 is continued to  
 20    November the 10th.

21           On Page 3, Case Number 14751 is continued to  
 22    December 15. Case Number 14741 is continued to December the  
 23    1st.

24           On the last page, Case Number 14629 is continued to  
 25    November 10. Case Number 14737 is dismissed.

1 Are there any continuances or dismissals at this  
2 time?

3 MR. FELDEWERT: Mr. Examiner, Michael Feldewert, if  
4 you look on Page 3 --

5 EXAMINER EZEANYIM: Okay.

6 MR. FELDEWERT: -- Case Number ~~14749~~ we are going  
7 to dismiss, so we are just going to proceed with 14750.

8 EXAMINER EZEANYIM: So let the record reflect that  
9 14749 will be dismissed. Is that correct?

10 MR. FELDEWERT: Yes, sir.

11 EXAMINER EZEANYIM: Case Number 14749 is dismissed.  
12 Any other dismissals or continuances?

13 (No response.)

14 EXAMINER EZEANYIM: Okay. And I think we have a  
15 live docket today, so I'm going to have to take it in the  
16 order of the docket, so -- okay. Let's continue.
