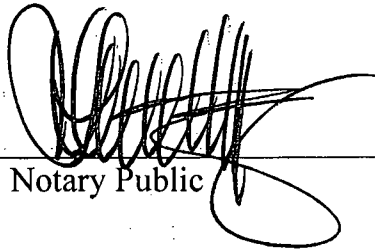

Re: Application of EOG Resources, Inc., to exclude the Leonard shale interval of the Bone Spring formation from the Special Rules and Regulations for the Red Hills-Bone Spring Pool, Lea County, New Mexico.

Ladies and Gentlemen:

This letter is to advise you that EOG Resources, Inc., has filed the enclosed application with the New Mexico Oil Conservation Division. Division rules require notice to Division-designated operators in the pool and to Division-designated operators of wells within the same formation as the pool and within one mile of the pool's outer boundary that have not been assigned to another pool.

This application has been set for hearing before a Division Examiner at 8:15 AM on November 10, 2011. The hearing will be held in Porter Hall in the Oil Conservation Division's Santa Fe Offices located at 1220 South Saint Francis Drive, Santa Fe, New Mexico 87505. You are not required to attend this hearing, but as an owner of an interest that may be affected by this application, you may appear and present testimony. Failure to appear at that time and become a party of record will preclude you from challenging the matter at a later date.

Parties appearing in cases are required by Division Rule 1208.B to file a Pre-Hearing Statement with the Oil Conservation Division's Santa Fe office, four days in advance of a scheduled hearing, but at least on the Thursday preceding the hearing. This statement must include: the names of the parties and their attorneys; a concise statement of the case; the names of all witnesses the party will call to testify at the hearing; the approximate time the party will need to present its case; and identification of any procedural matters that are to be resolved prior to the hearing.

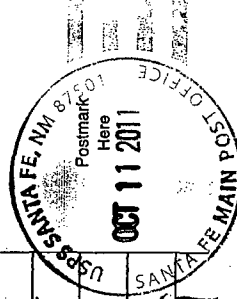
