**STATEMENT OF THE CASE**

Since the filing of the initial applications in these matters, COG Operating LLC has entered into an agreement with Nadel and Gussman Perman L.L.C. under which COG intends to drill the Patton 5 Fee Well No. 6 (formerly proposed as the Big Iron Well No. 1) as a horizontal well in the Glorieta-Yeso formation at a surface location in the NW $\frac{1}{4}$ SW $\frac{1}{4}$  and a terminus in the NE $\frac{1}{4}$ SE $\frac{1}{4}$  of Section 5, and the Patton 5 Fee Well No. 8 (formerly proposed as the Big Iron Well

No. 2) as a horizontal well in the Glorieta-Yeso formation at a surface location in the SW $\frac{1}{4}$ SW $\frac{1}{4}$  and a terminus in the SE $\frac{1}{4}$ SE $\frac{1}{4}$  of Section 5. COG therefore seeks an order (1) approving 160-acre non-standard oil spacing and proration units (project areas) in the Glorieta-Yeso formation comprised of the N/2 S/2 of Section 5 for the Patton 5 Fee Well No. 6 and the S/2 S/2 of Section 5 for the Patton Fee Well No. 8, and (2) pooling the remaining mineral interests in the Glorieta-Yeso formation underlying these non-standard spacing and proration units.


