10          Okay. Are there any additions or corrections?

11          MR. BRUCE: Mr. Examiner, Jim Bruce, since you -- on  
12 Page 9, the final three cases on Page 9 and 10, the Burnett

14          EXAMINER BROOKS: Very good. On Page 9, case Number  
15 14673 is continued to August 29, Case 14674 is continued to  
16 August 29, Case Number 14 -- and on Page 10, Case Number  
17 14691 continued to August 29.

18          MR. BRUCE: And then on Page 5, Mr. Examiner, I  
19 don't know if you called this one at the very top, 14659.

20          EXAMINER WARNELL: Didn't call that.

21          MR. BRUCE: Please continue that to September 1.

22          EXAMINER BROOKS: Case Number 14659 continued to  
23 September 1.

24          MS. MCGRAW: Are we working off the same docket?

25          MR. BRUCE: Kate, there was an amended docket which

1 you probably had. This is the -- you have the amended  
2 docket.

3 MS. MCGRAW: I picked up the one right back there.

4 EXAMINER BROOKS: Somebody must have put the wrong  
5 one.

6 MS. MCGRAW: She has this all wrong.

7 EXAMINER BROOKS: I don't know, that's -- Florene  
8 usually does that, and she doesn't make that many mistakes.

9 MS. MCGRAW: I guess I will get with Florene and  
10 find out what's going on.

11 MR. BRUCE: What happened, Mr. Examiner, if you  
12 start with Case 13 on Page 3, all of those dismissed Cimarex  
13 ones through the next page, they should have been dismissed  
14 at the last hearing, but they were carried through on the  
15 docket, so that's why Florene put out an amended docket  
16 sheet, which some people have.

17 EXAMINER BROOKS: Okay. Well, I'm glad I have the  
18 right one.
