Pursuant to State of New Mexico Oil Conservation Division Order No. R-13480, the Blinebry, Tubb and Drinkard pools were redesignated as the Warren-Blinebry-Tubb-Drinkard Oil and Gas Pool (Pool Code 62965), effective December 1, 2011.

ConocoPhillips Company's drilling program within the Warren Unit has been primarily focused on Blinebry-Tubb-Drinkard commingling projects. Because of the low reservoir pressure within the Warren Unit, the most efficient and economical method to produce this area is by a consolidation of the Blinebry-Tubb-Drinkard pools and the resulting consolidation of the existing Blinebry-Tubb-Drinkard Participating Areas. Production accountability will also be enhanced



BY THE DIVISION:

This case came on for hearing at 8:15 a.m. on November 10, 2011, at Santa Fe, New Mexico before Examiner David K. Brooks.

NOW, on this 16th day of November, 2011, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner,

FINDS THAT:

- (1) Due public notice has been given, and the Division has jurisdiction of this case and its subject matter.
- (2) There is need for the contraction of the Blinebry Oil and Gas Pool (Pool Code - Oil: 6660, Pro Gas: 72480) in Lea County, New Mexico, in order to correct nomenclature.
- (3) There is need for the contraction of the Warren-Drinkard Pool (Pool Code 63080) in Lea County, New Mexico, in order to correct nomenclature.
- (4) There is need for the contraction of the East Warren-Drinkard Pool (Pool Code 63120) in Lea County, New Mexico, in order to correct nomenclature.
- (5) There is need for the contraction of the East Warren-Tubb Pool (Pool Code 87085) in Lea County, New Mexico, in order to correct nomenclature.

(6) There is need for the extension of the vertical limits of the Warren-Blinebry-Tubb Oil and Gas Pool (**Pool Code 62965**) in Lea County, New Mexico, to include the Drinkard formation and the redesignation of the pool as the Warren-Blinebry-Tubb-Drinkard Oil and Gas Pool (**Pool Code 62965**).

(7) There is need for extensions to the Blinebry Oil and Gas Pool, the D-K-Drinkard Pool, the Drinkard Pool, and the Warren-Blinebry-Tubb-Drinkard Oil and Gas Pool, all in Lea County, New Mexico.


IT IS FURTHER ORDERED THAT:

(1) Pursuant to Section 70-2-18, NMSA, 1978, an operator of any well that, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one presently dedicated thereto, shall have 60 days from the effective date of this order to file Form C-102 dedicating a standard unit for the pool to that well or to obtain a non-standard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Division within that 60-day period shall subject the well to cancellation of allowable.


(2) The effective date of this order and all contractions, redesignations, and extensions of vertical and horizontal limits included herein shall be December 1, 2011.




Top Blinebry Structure Map


