- 1 EXAMINER WARNELL: Case 14759, amend the
- 2 application of COG Operating, LLC to increase well
- 3 density and pre-approval of non-standard locations in
- 4 the Burch Keely Federal Unit, Eddy County, New Mexico.
- 5 Call for appearances.
- 6 MR. FELDEWERT: Mr. Examiner, Michael
- 7 Feldewert with the Santa Fe office of Holland & Hart
- 8 appearing on behalf of the applicant. I do not have a
- 9 witness here today. I just have two additional exhibits
- 10 to offer the Division in order to address a notice issue
- 11 that arose when this case was heard in November.
- 12 EXAMINER BROOKS: Now this is the case that
- 13 was heard on --
- 14 EXAMINER WARNELL: On the 10th, yes.
- 15 EXAMINER BROOKS: Okay. Go ahead.
- MR. FELDEWERT: Mr. Examiner, at the prior
- 17 hearing the division requested that we readvertise, we
- 18 amend the application that was addressed at that hearing
- 19 to more completely incorporate the relief that was
- 20 testified to at that hearing. And then secondly to
- 21 provide additional notice to the Bureau of Land
- 22 Management.
- So what I'm offering here today is, in order to
- 24 keep it sequentially, Exhibit COG 18, which is an
- 25 affidavit of publication for the amended application

- 1 that was filed, and then COG Exhibit Number 19 is the
- 2 affidavit confirming that notice of this hearing and a
- 3 copy of the amended application was provided to the
- 4 operators affected here as well as the Bureau of Land
- 5 Management.
- And with that, with this additional notice, the
- 7 case, we believe, is ready to be taken under advisement
- 8 for purposes of considering the exceptions that have
- 9 been advertised and that were testified to at the
- 10 November hearing.
- 11 EXAMINER WARNELL: Very well. Exhibits 18
- 12 and 19 will be admitted.
- 13 Questions, Mr. Brooks?
- 14 [Exhibits 18 and 19 admitted.]
- 15 EXAMINER BROOKS: No questions. I would
- 16 assume that we will take case number 14759 under
- 17 advisement.
- 18 EXAMINER WARNELL: Case number 14759 will be
- 19 taken under advisement.
- 20 EXAMINER BROOKS: I also assume I will write
- 21 that one.
- 22 EXAMINER WARNELL: Well, we can get that on
- 23 the record, and I have the file here. So with that then
- 24 that includes docket 36-11, and we stand adjourned until
- 25 next year.
