REPORTER'S TRANSCRIPT OF PROCEEDINGS
PRE-HEARING TRANSCRIPT

This matter came on for hearing before the New Mexico Oil Conservation Division, RICHARD EZEANYIM, Hearing Examiner, on Thursday, February 2, 2012, at the New Mexico Energy, Minerals and Natural Resources Department, 1220 South St. Francis Drive, Room 102, Santa Fe, New Mexico.

1 HEARING EXAMINER EZEANYIM: This hearing
2 will come to order. Good morning everybody. Today is
3 February 2nd, at approximately 8:15 in the morning.
4 Today we're going to consider Docket Number 4-12.

5 And before I start with the docket, I wanted
6 to make an announcement for the record. The Division has
7 adopted a policy. This policy is unwritten. Anyway,
8 it's important, and we want to communicate it to
9 everybody that continuances are allowed three times only.
10 After the third continuance, the fourth time, the case
11 has to be heard or dismissed.

12 So how would that happen? I have been
13 communicating to all of the attorneys. From this hearing
14 today, February 2nd, I've just drawn a line across all
15 the cases that have been continued. There were four that
16 were continued for three or four times. Those ones don't
17 count. I just drew a line below it.

18 I will say, "First continuance, February 2nd
19 2012." If it's continued again, then that will be second
20 continuance. If it's continued again, that will be third
21 continuance, and that's it. Then it has to be heard in
22 that hearing. If it's going to be continued, then that
23 case will be dismissed.

24 So we want to grandfather all continuances
25 before we start this process. We want to clean up the

1 docket, because a lot of them have been sitting on the
2 docket for years and we don't know what to do with them.
3 So we want to allow all the operators to decide what they
4 want to do.

5 One thing you can do is, if you want to
6 continue it, you can continue it for six months, that's
7 one continuance. You can continue it for one year,
8 that's one continuance. If you continue it for two
9 weeks, that's one continuance; one month, one continuance;
10 two months -- so if you think you are not going to use
11 that application, you can continue it for a longer time
12 to decide what you want to do so that it's not dismissed
13 after you continue it for two weeks, three weeks and so
14 forth. So that's how we want to see if we can clean up
15 our docket.

16 Now, as you can see, the room is empty. The
17 first order of business is to continue with the
18 dismissals and continuances on Docket Number 4-12. We go
19 to page 1. On page 1, Case Number ~~14787~~ is continued to
20 March 1st, and that is the first continuance for this
21 case. Usually they have been continued for a long time.

22 On page 2, Case Number 14746 is continued to
23 March 1st; Case Number 14671 is dismissed; Case Number
24 14754 is dismissed; Case Number 14779 is dismissed.

25 On page 3, Case Number 14780 is dismissed;

1 Case Number 14686 is continued to March 1st; Case Number
2 14687 is continued to March 1st; Case Number 14659 is
3 continued to March 1st; Case Number 14767 is continued to
4 March 15th.

5 Page 4, Case Number 14768 is continued to
6 March 15th; Case Number 14769 is continued to March 15th;
7 Case Number 14770 is continued to March 15th; Case Number
8 14771 is continued to March 15th.

9 Page 5, Case Number 14772 is continued to
10 March 15th; Case Number 14781 is continued to March 15th;
11 Case Number 14791 is continued to March 15th; Case Number
12 14792 is continued to March 15th; Case Number 14793 is
13 continued to March 15th.

14 Page 6, Case Number 14794 is continued to
15 March 15th; Case Number 14795 is continued to March 15th;
16 Case Number 14629 is dismissed.

17 Are there any other continuances or dismissals
18 at this time?

19 MR. FELDEWERT: Mr. Examiner, Michael
20 Feldewert, with Holland & Hart, appearing on behalf of
21 the applicant Caza Petroleum in Case 14789. We ask that
22 that case be continued for two weeks.

23 HEARING EXAMINER EZEANYIM: So February
24 16th?

25 MR. FELDEWERT: I believe that's the next


1 hearing date, yes.


