APPLICANT'S STATEMENT OF CASE

COG Operating LLC seeks an order: (1) creating a non-standard 160-acre spacing and proration unit comprised of the W/2 W/2 of Section 3, Township 19 South, Range 26 East, NMPM, and (2) pooling all mineral interests in the Glorieta-Yeso formation underlying this non-standard spacing and proration unit. This proposed non-standard spacing and proration unit will be the project area for the Lee 3 Fee Well No 1H to be horizontally drilled from a surface

location 330 feet from the South line and 380 feet from the West line (Unit M) to a bottom hole
location 330 feet from the North line and 380 feet from the West line (Unit D) of Section 3.


