2. **CASE 14854: Application of Lime Rock Resources II-A, LP, for approval of a salt water disposal well, Eddy County, New Mexico.** Applicant seeks an order proposing to re-enter an existing plugged and abandoned wellbore, to convert to a salt water disposal its Oxy Peso #1, located 1650 feet from the North line and 1850 feet from the West line, Unit F, Section 24, Township 18 South, Range 27 East, NMPM, Eddy County, New Mexico. The well is located approximately 16 miles southeast of Artesia, New Mexico.
3. **CASE 14855: Application of COG Operating LLC for Compulsory Pooling, Eddy County, New Mexico.** Applicant seeks an order pooling all mineral interests in the SW/4 NE/4 of Section 16, Township 17 South, Range 31 East, NMPM, Eddy County, New Mexico, to form a standard 40-acre spacing and proration unit for any and all formations and or pools developed on 40 acres from the surface to the base of the Glorieta-Yeso formation, Mar Loco Glorieta Pool (79866). Applicant seeks an order consolidating the 40-acre spacing units within the N/2 S/2 of Section 34, Township 19 South, Range 29 East, NMPM and designating the consolidated units as a 160-acre± non-standard oil spacing and proration unit for a well location in the Bone Spring formation for Applicant's horizontal drilling project area. Applicant further seeks the compulsory pooling of all interests in the Bone Spring formation underlying the N/2 S/2 of Section 34 to be dedicated to its Osage "34" Federal No. 3H Well to be drilled horizontally from a surface location 1880' from the South line and 330' from the West line (Unit L) to a bottomhole location 1980' from the South line and 330' from the East line (Unit I) to a depth sufficient to test the Bone Spring formation, Parkway Bone Spring pool (49622). Applicant seeks an order consolidating the 40-acre spacing units within the N/2 S/2 of Section 35, Township 19 South Range 29 East, NMPM and designating the consolidated units as a 160-acre± non-standard oil spacing and proration unit for a well location in the Bone Spring formation for Applicant's horizontal drilling project area. Applicant further seeks the compulsory pooling of all interests in the Bone Spring formation underlying the N/2 S/2 of Section 35 to be dedicated to its Parkway "35" Federal No. 3H Well to be drilled horizontally from a surface location 2080' from the South line and 330' from the West line (Unit L) to a bottom hole location 1980' from the South line and 330' from the East line (Unit I) to a depth sufficient to test the Bone Spring formation, Parkway Bone Spring pool (49622).
