**STATEMENT OF CASE**

Applicant seeks an order proposing to drill and utilize its Eddy-Humble "4" State No. 1, located 2,310 FSL and 1,650 FEL, Unit J, Section 4, Township 18 South, Range 28 East, N.M.P.M., Eddy County, New Mexico. Applicant proposes to set a packer at 6,625 feet below the surface of the earth or within 100 feet of the upper most injections perforations and then inject into the Abo, Wolfcamp and Cisco formations at the following depths, 6,705 feet through 6,805 feet perforated; and, 6,805 feet through 9,300 feet open hole.
