21. **CASE 14807:** (Continued from the March 29, 2012 Examiner Hearing.)
Application of Burgundy Oil & Gas of New Mexico, Inc. for compulsory pooling, Lea County, New Mexico. Applicant in the above-styled cause seeks an order pooling all mineral interests from the surface to the base of the Paddock formation, the Lovington Paddock Pool, in a standard 40-acre, more or less, oil spacing and proration unit comprised of Unit Letter M, Section 28, Township 16 South, Range 37 East, N.M.P.M., Lea County, New Mexico, which is to be dedicated to the Homestake No. 1 Well (API# 30-025-05343) at a standard oil well location 660 feet from the South and West lines of said Section. Application of Legacy Reserves Operating LP for approval of a salt water disposal well, Eddy County, New Mexico. Applicant in the above-styled cause seeks an order authorizing injection for purposes of salt water disposal in the Andrew Arnquist Estate No. 2 Well, at a surface location 330 feet from the North line and 330 feet from the East line of Section 29, Township 18 South, Range 26 East, N.M.P.M., Eddy County, New Mexico. The target injection formation is the Cisco Canyon formation at a depth of approximately 7,750 feet to 8,100 feet. Said well is located approximately 1.5 miles southwest of Dayton, New Mexico.
23. **CASE 14829:** ***Application of COG Operating, LLC for a non-standard spacing and proration unit and compulsory pooling, Eddy County, New Mexico.*** Applicant seeks an order (1) creating a non-standard 160-acre spacing and proration unit comprised of the W/2 W/2 of Section 3, Township 19 South, Range 26 East, NMPM, Eddy County, New Mexico; and (2) pooling all mineral interests in the Yeso formation underlying this acreage. Said non-standard unit is to be dedicated to applicant's proposed Lee 3 Fee Well No. 1H, to be horizontally drilled from a surface location 330 feet from the South line and 380 feet from the West line (Unit M) to a bottom hole location 330 feet from the North line and 380 feet from the West line (Unit D) of Section 3. 24. **CASE 14830:** ***Application of COG Operating, LLC for a non-standard spacing and proration unit and compulsory pooling, Eddy County, New Mexico.*** Applicant seeks an order (1) creating a non-standard 160-acre spacing and proration unit comprised of the E/2 W/2 of Section 31, Township 18 South, Range 26 East, NMPM, and (2) pooling all mineral interests in the Glorieta-Yeso formation underlying this acreage. Said non-standard unit is to be dedicated to applicant's proposed Falabella "31" Fee Well No. 6H, to be horizontally drilled from a surface location 150 feet from the South line and 2260 feet from the West line (Unit N) to a bottom hole location 330 feet from the North line and 2260 feet from the West line (Unit C) of Section 31. Also to be considered will be the cost of drilling and completing said well and the allocation of the cost thereof as well as actual operating costs and charges for supervision, designation of COG Operating, LLC as operator of the well and a 200% charge for risk involved in drilling said well. Said area is located approximately 17 miles North of Carlsbad, New Mexico.
25. **CASE 14831:** ***Application of COG Operating, LLC for a non-standard spacing and proration unit and compulsory pooling, Eddy County, New Mexico.*** Applicant seeks an order (1) creating a non-standard 160-acre spacing and proration unit comprised of the W/2 E/2 of Section 31, Township 18 South, Range 26 East, NMPM, and (2) pooling all mineral interests in the Glorieta-Yeso formation underlying this acreage. Said non-standard unit is to be dedicated to applicant's proposed Falabella "31" Fee Well No. 7H, to be horizontally drilled from a surface location 150 feet from the South line and 1700 feet from the East line (Unit O) to a bottom hole location 330 feet from the North line and 1700 feet from the East line (Unit B) of Section 31. Also to be considered will be the cost of drilling and completing said well and the allocation of the cost thereof as

well as actual operating costs and charges for supervision, designation of COG Operating, LLC as operator of the well and a 200% charge for risk involved in drilling said well. Said area is located approximately 17 miles North of Carlsbad, New Mexico.

26. **CASE 14687:** (Continued from the March 29, 2012 Examiner Hearing.) ***Application of Cimarex Energy Co. for a non-standard oil spacing and proration unit and compulsory pooling, Chaves County, New Mexico.*** Cimarex Energy Co. seeks an order approving a non-standard oil spacing and proration unit (project area) in the Abo/Wolfcamp formation comprised of the N/2 S/2 of Section 20, Township 15 South, Range 31 East, NMPM, to form a non-standard 160.00-acre oil spacing and proration unit (project area), and pooling all mineral interests in the Abo/Wolfcamp formation underlying the non-standard unit. The unit is to be dedicated to the Valley Forge 20 State Com. Well No. 2, a horizontal well to be drilled at a surface location 1980 feet from the south line and 375 feet from the west line, with a terminus 1980 feet from the south line and 375 feet from the east line, of Section 20. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of Cimarex Energy Co. of Colorado as operator of the well, and a 200% charge for the risk involved in drilling and completing the well.
