1. **CASE 14835:** *(Reopened)*  
***Application of Coulthurst Management & Investment, LLC, for Authorization to Inject as Part of a Pressure Maintenance Project, Sandoval County, New Mexico.*** Applicant in the above-styled cause seeks authorization to inject produced water in the Menefee formation, South San Luis-Mesaverde Pool, through the Erin No. 2 well (API 30-043-20862), located 990 feet from the North line and 2310 from the West line (Unit C) of Section 33, township 18 North, Range 3 West, N.M.P.M., Sandoval County, New Mexico. The proposed project area is approximately 520 acres in size, consisting of the W/2, N/2 NE/4, N/2 SE/4, SE/4 SE/4 of said Section. The Erin No. 2 well and proposed project area are located approximately 6 miles southeast of Torreon, New Mexico.
2. **CASE 14875:** ***Application of Armstrong Energy Corporation for compulsory pooling, Roosevelt County, New Mexico.*** Applicant seeks the pooling of all uncommitted mineral interests from the surface to the base of the Fusselman formation in the SW/4 NW/4 of Section 31, Township 5 South, Range 34 East, NMPM. The standard 40-acre unit is to be dedicated to the Ruby Tuesday #1, a vertical well to be drilled at an orthodox location. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well a actual operating costs and charges for supervision, the designation of Armstrong Energy Corporation as the operator of the well, and a 200% charge for the risk involved in drilling and completing the well. The well will be located approximately five miles east of Pep, New Mexico.
3. **CASE 14876:** ***Application of Thompson Engineering and Production Corporation for approval of a unit agreement, San Juan County, New Mexico:*** Applicant seeks approval of the Unit Agreement for the PGA Exploratory Unit Area, comprising 8,436.83 acres of federal and state lands covering all or part of Sections 2-4, 8-10, and 16 in Township 23 North, Range 11 West, NMPM, and Sections 21, 22, 25-28, and 33-35 in Township 24 North, Range 11 West, NMPM. The proposed unit area is centered approximately 6 miles southwest of the Blanco Trading Post.
