STATEMENT OF THE CASE

APPLICANT

Energen Resources Corporation is requesting the Division to issue an order (1) Approving the establishment of a Special Infill Well Development Area in portions of the Gavilan-Pictured Cliffs Pool (77360) in Rio Arriba, County, New Mexico; (2) Providing for an exception to the well density development limitations applicable to the pool to allow two producing gas wells per 160-acre spacing unit throughout the Special Infill Well Development Area; (3) Authorizing recompletions of 35 existing Mesaverde formation wells in the Pictured Cliffs formation and approving unorthodox well locations for certain of those wells; (4) Authorizing the dual completions of 7 new wells to be drilled to both formations; and (5) for area-wide downhole commingling. The Special Infill Well Development area is a contiguous block comprised of approximately 12,207.60 acres, all of which are under lease to and operated by Energen. Notice was provided pursuant to Rules 15.11 C and 15.13.
