1 MR. EXAMINER: Good morning again, ladies  
2 and gentlemen. I'm sorry we are five minutes late.

3 Today is July 12th, Thursday, July 12th, and we  
4 are going to consider docket number 21-12. We have a  
5 big docket today. As always, first of all, we call all  
6 the continuances and dismissals, and we start on page 2;  
7 case number 14825 is dismissed. On page 3, case number  
8 14864 is dismissed. On page 4, case number 14880 is  
9 continued to July 26. Case number 14863 is continued to  
10 July 26. Case number 14863 is continued to July 26th.  
11 Case number 14819 is dismissed.

12 Page 5, all these four cases are dismissed; case  
13 number 14820, case number 14821, case number 14822, case  
14 number 14823. These four cases will be dismissed  
15 without prejudice because they have been continued for  
16 more than three times.

17 Are there any other dismissals or continuances at  
18 this point? In that case we are going to have 13 cases  
19 today. This is what I'm thinking, we're going to do  
20 case number 14878 last. The other cases are simply  
21 shorter, we can do them. So we'll do the case number  
22 14878 as the last case. Is that going to present a  
23 problem? If that's not going to present a problem then  
24 I will go into the docket.


