As we transmit these documents to the Division, we wish to advise the Division and the Applicant, Heritage Petroleum, Inc., that the Nation may need to request a continuance of the currently-scheduled September 20 hearing date. Included in the filings herewith is a written request for the Division to issue subpoenas to require two employees of the Bureau of Indian Affairs to testify and produce documents at the hearing. Along with our request to the Division, we have also transmitted *Touhy* requests to the Department of the Interior, pursuant to the



Department of the Interior's regulations. Approval of these requests is necessary to allow these federal employees to testify and produce documents at the hearing. Based on our prior experience, we believe it is unlikely that the Department of the Interior will approve our *Touhy* requests prior to the September 20 hearing date. We will communicate with the Department of the Interior to determine whether or not it will be able to approve the Nation's requests prior to September 20. If approval by September 20 is not possible, we will file a formal request for continuance of the September 20 hearing date. We wanted to alert you and the Applicant as to this possibility at the earliest date.
