CASE 13458: *Continued from April 17, 2005, Examiner Hearing*
Application of OXY USA WTP Limited Partnership for compulsory pooling, Eddy County, New Mexico. Applicant seeks an order pooling all mineral interests from the surface to the base of the Morrow formation underlying the S/2 of Section 5, Township 17 South, Range 27 East, forming a standard 320-acre gas spacing and proration unit for any production from any and all formations/pools developed on 320-acre spacing within that vertical extent, including but not limited to the Crow Flats-Morrow Gas Pool. This unit is to be dedicated to its OXY Vision Federal Com Well No. 1 to be drilled at a standard well location in Unit M of this section. Also to be considered will be the costs of drilling and completing this well and the allocation of the costs thereof as well as actual operating costs and charges for supervision, designation of OXY USA WTP Limited Partnership as the operator of the well and, pursuant to Commission Order R-11992, a risk charge of 200% for the risk involved in this well. This unit is located approximately 5 miles East from Artesia, New Mexico.
