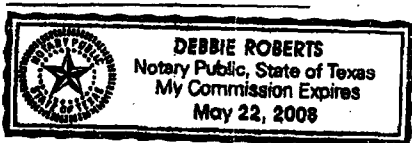
1. I am over the age of eighteen, and have personal knowledge of the matters stated herein.
