CASE 13486: Continued and Readvertised

Application of Synergy Operating, LLC for compulsory pooling, San Juan County, New Mexico. Applicant seeks an order pooling all mineral interests from the surface to the base of the Fruitland Coal formation underlying the following described acreage in Section 8, Township 29 North, Range 11 West, and in the following manner: The W/2 to form a standard 320-acre gas spacing and proration unit for any pools or formations developed on 320-acre spacing within that vertical extent, including the Basin-Fruitland Coal Gas Pool; and the SW/4 to form a standard 160-acre gas spacing and proration unit for any pools or formations developed on 160-acre spacing within that vertical extent, including the Undesignated Bloomfield-Farmington Pool. Application of Samson Resources Company for compulsory pooling, Eddy County, New Mexico: Applicant seeks an order pooling all mineral interests from the base of the Bone Spring formation to the base of the Morrow formation underlying the E/2 of Section 17, Township 18 South, Range 30 East, to form a standard 320-acre gas spacing and proration unit for any and all formations or pools developed on 320-acre spacing within that vertical extent, including the Undesignated Sand Tank-Strawn Gas Pool and Undesignated Sand Tank-Morrow Gas Pool. The unit is to be simultaneously designated to the proposed Sand Tank "17" Fed. Com. Well No. 2, to be located at an orthodox well location in the NE/4 SE/4 of Section 17, and to the existing Sand Tank "17" Fed. Com. Well No. 1, located at an approved unorthodox location in the SE/4 NE/4 of Section 17. The unit is located approximately 1 mile northeast of Otis, New Mexico.

The unit is located approximately 5 miles south-southeast of Black River Village, New Mexico.
