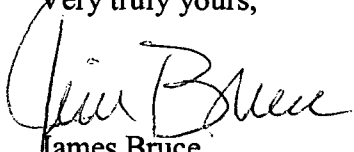
Dear Mr. Ezeanyim:

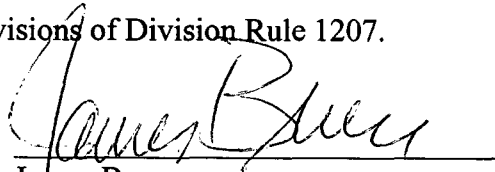

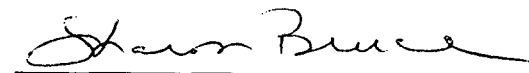

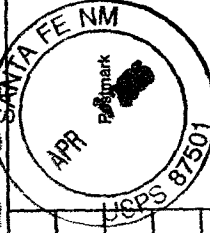
