



REQUEST FOR CLARIFICATION

A hearing was held in this case on May 23, 2005, before Hearing Examiner William V. Jones of the Oil Conservation Division ("the Division" or "OCD"). Order No. R-12306-B, denying GMI's application for a permit modification, was issued by the Division on August 5, 2005. The Order includes two sections: Section I titled "Decision" and Section II titled "Order." In the "Order" section, the Division provides GMI with the opportunity to submit a revised application "in conformity with Rule 711." (Order No. R-12306, at p.19, ¶8, p. 20, ¶3, 4). The Order also states that the revised application, after submittal by GMI and public notice, will be referred by the Division Director directly to the Commission for further proceedings. (*Id.* at p. 20, ¶5).


The "Decision" section of Order No. R-12306 includes a lengthy discussion of the requirements for a permit modification application under Rule 711 and a number of statements and recommendations concerning the permit modification. GMI requests a clarification from the Division that, if GMI files a revised application, the statements and technical recommendations in the "Decision" section of Order No. R-12306, including but not limited to those in Sections I, K, and the 6th and 7th paragraphs of Section J, are advisory and will not be binding on the parties or the Commission.
