Gentlemen:

In accordance with Section 10 of the Poker Lake Unit Agreement dated March 18, 1952, Bass Enterprises Production Co., Operator of the referenced unit, hereby submits a Plan of Development for the Poker Lake Unit for the year 1995.

**HISTORY OF PAST DEVELOPMENT**

We refer to our previous Plans of Development for a detailed description of the operations conducted in this Unit in prior years.

**1994 ACTIVITY**

Poker Lake Unit Well No 79 - This well was drilled at a location being 660' FSL & 660' FWL, Section 2, T25S-R30E, Eddy County, New Mexico. This well was drilled to a total depth of 8,000' and completed as an oil well in the Delaware formation in the intervals 7,720' - 7,746'. This well will be submitted during the calendar year 1995, for commercial determination and a participating area.

Poker Lake Unit Well No. 82 - This well was drilled at a location 660' FSL and 660' FEL, Section 24, T24S-R30E, Eddy County, New Mexico. The well was drilled to a total depth of 8,295' and completed as an oil well in the Delaware formation from perforations 7,853' - 7,980'. This well has been determined to be commercial and is part of the Delaware "B" Participating Area.

Poker Lake Unit Well No. 83 - This well was drilled at a location being 660' FNL & 660' FWL, Section 30, T24S-R30E, Eddy County, New Mexico. This well has been determined to be commercial and is part of the Delaware "B" Participating Area.

Poker Lake Unit Well No. 85 - This well was drilled at a location being 1,930' FNL & 710' FEL, Section 25, T24S-R30E, Eddy County, New Mexico. This well was drilled to a total depth of 8,150' and completed as an oil well in the Delaware formation in the intervals 7,803' - 7,954'. This well will be submitted during the calendar year 1995, for commercial determination and a participating area.

Poker Lake Unit Well No. 87 - This well was drilled at a location 1,880' FEL and 610' FNL, Section 25, T24S-R30E, Eddy County, New Mexico. The well was drilled to a total depth of 8,150' and completed as an oil well in the Delaware formation in the intervals 7,838' - 7,991'. This well will be submitted during the calendar year 1995, for commercial determination and a participating area.

Poker Lake Unit Well No. 89 - This well was drilled at a location being 2,310' FNL & 1,980' FEL, Section 25, T24S-R30E, Eddy County, New Mexico. This well was drilled to a total depth of 8,150' and completed as an oil well in the Delaware formation in the intervals 6,670' - 6,769'. This well will be submitted during the calendar year 1995, for commercial determination and a participating area.

Poker Lake Unit Well No. 98 - This well was drilled at a location 1,980' FNL and 660' FWL Section 30, T24S-R31E, Eddy County, New Mexico. The well was drilled to a total depth of 8,200' and completed in the Delaware formation in the intervals 7,983' - 8,001'. This well is within the Delaware "B" Participating Area and deemed commercial.

Poker Lake Unit Well No. 103 - This well was drilled at a location 1,980' FNL and 1,980' FWL, Section 25, T24S-R30E, Eddy County, New Mexico. This well was drilled to a total depth of 8,100' and completed as an oil well in the Delaware formation in the intervals 7,882' - 7,912'. This well will be submitted during the calendar year 1995, for commercial determination and a participating area.

Poker Lake Unit Well No. 107 - This well was drilled at a location being 1,980' FSL & 660' FEL, Section 26, T24S-R30E, Eddy County, New Mexico. This well was drilled to a total depth of 8,100' to test the Delaware. This well was plugged and abandoned.

### PARTICIPATING AREAS

Bass Enterprises Production Co. has submitted all wells drilled to date where adequate production information is available for commercial determination and participating areas. In the event you have not received commercial determination for the wells that have been drilled and completed and are currently producing, please advise at your convenience and we will submit same to you.

### FUTURE DEVELOPMENT

Poker Lake Unit Well No. 105 - This well will be drilled at a location being 660' FNL, 1,980' FEL of Section 36, T24S-R30E, Eddy County, New Mexico to a proposed depth of 8,200' to test the Delaware Formation.

Poker Lake Unit Well No. 116 - This well will be drilled at a legal location 1,980' FWL, 1,980' FSL of Section 36, T24S-R30E, Eddy County, New Mexico to a proposed depth of 8,200' to test the Delaware formation.

### OFFSET OBLIGATIONS

Appropriate and adequate measures will be taken to prevent drainage of unitized substances from lands covered by the Poker Lake Unit Agreement or pursuant to applicable regulations.

### MODIFICATIONS

In accordance with the terms and provisions of the Poker Lake Unit Agreement, this Plan of Development may be modified from time to time as a result of changing conditions.

### EFFECTIVE DATE

This Plan of Development shall become effective on January 1, 1995.



Please reference that certain 1995 Plan of Development for the Poker Lake Unit submitted by Bass Enterprises Production Co. by letter dated February 27, 1995, a copy of which is attached hereto. In that regard, Bass hereby submits an amendment to said 1995 Plan of Development to add two wells which Bass intends to commence during 1995 as follows:

Poker Lake Unit Well No. 123 - This well will be drilled at a location 1,980' FSL, 1,980' FWL of Section 22, T24S-T31E, Eddy County, New Mexico to a proposed depth of 15,400' to test the Morrow Formation.

Poker Lake Unit Well No. 97 - This well will be drilled at a legal location 660' FNL and 1,980' FWL of Section 22, T24S-R31E, Eddy County, New Mexico to a proposed depth of 15,400' to test the Morrow Formation.

The Bureau of Land Management by their letter of July 17, 1995, has advised this office that the Poker Lake Unit Well Nos. 62, 63, 64, and 65 were determined to be capable of producing in paying quantities from the Delaware formation. In addition, the Unit Well Nos. 61, 66, and 68 were considered to be non-paying wells and are to produced on a lease basis.

Please be advised that the Commissioner of Public Lands concurs with the Bureau of Land Management's determinations that the Poker Lake Unit Well Nos. 62, 63, 64, 65 are commercial in the Delaware formation and entitled to participate in the Delaware Participating Area. The Well Nos. 61, 66 and 68 are considered to be non-paying wells and will be produced on a lease basis.

Please submit an application for the appropriate expansion of the Delaware Participating Area to this office for approval.


