Gentlemen:

In compliance with Section 10 of the Poker Lake Unit Agreement, dated July 16, 1952, Perry R. Bass, as Unit Operator, hereby submits for your approval Plan of Development covering the period from June 1, 1962 to June 1, 1963.

History of Past Development

In reviewing the past development of the Poker Lake Unit, we are attaching hereto a map marked "Exhibit A" which reflects all of the wells drilled within this unit area since its inception. You will note that the deep tests are marked in red, all of which wells were drilled below 13,500 feet. The Richardson & Bass No. 1 Harrison, which was completed as a dry hole May 22, 1954, was drilled to a total depth of 16,705 feet. This well was drilled in the NW $\frac{1}{4}$  NW $\frac{1}{4}$  of Section 12, Township 25 South, Range 30 East. The next deep test was located in the NE $\frac{1}{4}$  NE $\frac{1}{4}$  of Section 1, Township 25 South, Range 30 East, and was completed as a dry hole September 5, 1955 at a total depth of 13,792 feet. The third deep test was drilled in the NW $\frac{1}{4}$  SW $\frac{1}{4}$  of Section 22, Township 25 South, Range 30 East, and was completed on March 24, 1956 at a total depth of 14,883 feet. In addition to the deep tests as outlined above, there have been 21 wells drilled within the unit area as of June 1, 1962. These tests varied in depth from 3,500 to 4,500 feet and, as reflected on the plat, have been scattered throughout the unit in an effort to find Delaware and Lower Delaware production.

The present participating area covers the NW $\frac{1}{4}$  NW $\frac{1}{4}$  of Section 17 and the NE $\frac{1}{4}$  NE $\frac{1}{4}$  of Section 18, Township 25 South, Range 30 East. The initial

participating area and the first revision of same have been approved, and the latest revision is effective as of June 1, 1960.

Development


Perry R. Bass, as Unit Operator, plans to drill, or cause to be drilled, at least three additional Delaware tests or Lower Delaware tests in the period from June 1, 1962 to June 1, 1963. The location of these tests will depend upon the available geological data as obtained from continued studies, and an effort will be made to enlarge the present participating area and develop other production within the unit area.

Effective Date

This Plan of Development shall be effective June 1, 1962 and expire June 1, 1963.
