1 WHEREUPON, the following proceedings were had at  
2 8:18 a.m.:

3 EXAMINER JONES: Okay, let's go on the record  
4 this morning and call Docket Number 24-05. This is the  
5 Examiner hearing for August the 11th, 2005.

6 My name is William Jones, I'll be the appointed  
7 Hearing Examiner today. And Gail MacQuesten, division  
8 attorney.

9 Thanks, everyone, for coming today, and let's  
10 first call the continuances and dismissals. And after I'm  
11 done with what I know about, well, be sure and let me know  
12 about any others.

13 On the first page, Case 13,533 is continued to  
14 September the 8th; Case 13,527 continued to August 25th;  
15 Case 13,528 continued to August 25th.

16 Page 2, Case 13,536 continued to September the  
17 8th; Case 13,531 -- that's actually a "1" instead of a "7"  
18 for the Yates/Pride case there, the second from the bottom  
19 -- is continued to August 25th.

20 Page 3, Case 13,539 is continued to August 25th;  
21 Case 13,524 is dismissed; and Case 13,505 is actually  
22 continued to August 22nd. Is that --

23 MR. BRUCE: Yeah, that's correct, Mr. Examiner.

24 EXAMINER JONES: Okay, that's -- that should have  
25 been in the letter I sent out earlier, along with the other

1 two cases, and I'll correct that and add that to the letter  
2 and send it out again for the big hearing that's coming up  
3 on August 22nd and 23rd.

4 On the fourth page, the top two cases, Case  
5 13,492 and Case 13,493 are also part of that, and they'll  
6 be continued until August 22nd, special hearing date.

7 Any other continuances or dismissals?

8 MR. BRUCE: Mr. Examiner, the final case, 13,494,  
9 that's Mr. Kellahin's case, but I've handed you an e-mail  
10 from Mr. Kellahin authorizing you to continue that case for  
11 two weeks.

12 EXAMINER JONES: Okay, that -- Case 13,494 will  
13 be continued to August 25th.

14 Any other continuances or dismissals? Okay.


