1                   EXAMINER JONES: This is the Examiner  
2 hearing for Thursday, November 1st, 2012. This is Docket  
3 Number 35-12. I'm William V. Jones. This is David  
4 Brooks. I'll be the presiding Examiner today, and David  
5 Brooks will be the co-Examiner and Legal Examiner.

6                   First, let's call the continuances and  
7 dismissals. On page 1, Case 14907 is continued to  
8 November 29th; Case 14908 is dismissed; Case 14917 is  
9 continued to November 29th. Case 14917, the submittal  
10 was to continue it until the 15th of November. But we  
11 don't have a hearing -- our next hearing is November  
12 29th, so that case has been continued to November 29th.  
13 Case 14912 is dismissed.

14                   On page 2, Case 14919 is continued to November  
15 29th. Page 3, Case 14913 is continued to November 29th;  
16 Case 14921 and Case 14922 and Case 14923 are all three  
17 continued to November 29th. I understand those are all  
18 sort of together.

19                   And on page 4, Case 14915 is continued to  
20 November 29th; and Case 14925 is dismissed.

21                   Any other continuances or dismissals?

22                   MR. FELDEWERT: Mr. Examiner, I may have  
23 missed it. On page 2, Case 14911 -- I'm Michael  
24 Feldewert on behalf of COG. That case will be continued  
25 to 11/29.


