**STATEMENT OF THE CASE**

Applicant seeks an order from the Division: (1) creating a non-standard 160-acre, more or less, oil spacing and proration unit in the Upper Pennsylvanian formation, comprised of the N/2 N/2 of Section 36, Township 18 South, Range 31 East, NMPM, Eddy County, New Mexico; and (2) pooling all mineral interests in the Upper Pennsylvanian formation underlying this proposed non-standard spacing and proration unit. This proposed non-standard spacing and proration unit will be the project area for the Chicken Dinner 36 State Com Well No. 1H, to be horizontally drilled from a surface location 660 feet from the North line and 180 feet from the East line to a bottomhole location 760 feet from the North line and 660 feet from the West line of Section 36. The completed interval for this well will be within the 330-foot standard offset required by the rules. Also to be considered will be the cost of drilling and completing said well, the allocation of these costs as well as the actual operating costs and charges for supervision, designation of

COG Operating LLC as operator of the well, and a 200% charge for risk involved in drilling said well. Said area is located approximately 9 miles Southeast of Loco Hills, New Mexico.


