

The units are to be dedicated to the Guitar 10 Well No. 1, to be re-entered in the NW/4NE/4 of Section 10. Also to be considered will be the cost of re-entering and completing the well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of Guardian Operating Corp. as operator of the well, and a 200% charge for the risk involved in re-entering and completing the well. The application is scheduled to be heard at 8:15 a.m. on Thursday, November 29, 2012 at the Division's offices at 1220 South St. Francis Drive, Santa Fe, New Mexico 87505. As an interest owner in the well units you have the right to enter an appearance and participate in the case. Failure to appear will preclude you from contesting this matter at a later date.
