STATEMENT OF THE CASE

APPLICANT

Cimarex Energy Co. seeks an order approving a 280-acre non-standard oil spacing and proration unit (project area) in the Bone Spring formation comprised of the E/2NE/4, SW/4NE/4, E/2SW/4, SW/4SW/4, and NW/4SE/4 of Section 26, Township 20 South, Range 32 East, NMPM, Lea County, New Mexico. Applicant further seeks the pooling of all mineral interests in the Bone Spring formation underlying the non-standard unit (project area) for any pools or formations developed on 40 acre spacing within that vertical extent. The unit is to be dedicated to the Snoddy Fed. Well No. 22, a horizontal well to with a surface location in the NE/4NE/4,

and a terminus in the SW/4SW/4, of Section 26. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, actual operating costs and charges for supervision, designation of applicant as operator of the well, and a 200% charge for the risk involved in drilling and completing the well.
