As to the Tipton case, I am not getting any response from the State Land Office legal department on the waiver that you requested. However, in this regard, the State Land Office was notified twice of the application. When the application was filed administratively notice was given to the Land Office. When the application was set for hearing the Land Office was sent notice another notice of the hearing by my office. In neither case was there any objection by the State Land Office. I feel that we complied with the notice requirements as to the unleased 40 acre tract, being the SE/4NW/4 of Section 36.

Please let me know if you will still require a waiver from the State Land Office.
