Applicant seeks an order amending Order No. R-10154 which pooled all interests in the Fruitland Coal formation, Basin-Fruitland Coal Gas Pool (71629), underlying the S/2 of Section 19, Township 30 North, Range 11 West NMPM in San Juan County, New

Mexico, forming a standard 326.26 acre ± spacing and proration unit, now dedicated to the Flora Vista “19” Well No. 2 and the Flora Vista “19” Well No. 3 in San Juan County, New Mexico. Energen seeks an amendment to the referenced order to consolidate the interests of two mineral interest owners, Frank A. King and Paula S. Elmore, who claim that the oil and gas lease covering their interests terminated before Order No. R-10154 was issued.
