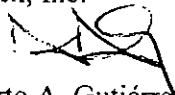
This letter is to advise you that DCP Midstream LP ("DCP") filed the enclosed application on December 10, 2013, with the New Mexico Oil Conservation Commission seeking authorization to drill two Acid Gas Injection (AGI) wells at their proposed Zia Plant (the "Plant") in Lea County, New Mexico. The proposed wells will be located in Section 19, Township 19 South, Range 32 East, NMPM, Lea County, New Mexico. DCP plans to inject up to 15 million standard cubic feet per day (MMSCFD) of treated acid gas from the Plant at a maximum pressure of 2,233 psi into these wells in the Lower Cherry Canyon and Upper Brushy Canyon Formations, approximately 5,470 to 6,070 feet below the surface. The proposed wells will serve as the disposal wells for acid gas at this new plant.

This application (Case Number 15073) has been set for hearing before the New Mexico Oil Conservation Commission at 8:15am on February 13th, 2014, in Porter Hall at the New Mexico Oil Conservation Division's Santa Fe office located at 1220 South Saint Francis Drive, Santa Fe, New Mexico 87505. You are not required to attend this hearing, but as an owner of an interest that may be affected by DCP's application, you may appear and present testimony. Failure to appear at that time and become a party of record will preclude you from challenging the application at a later date.

A party appearing at the hearing is required by Division Rule 19.15.4.13 NMAC to file a Pre-Hearing Statement at least four days in advance of a scheduled hearing, but in no event not later than 5:00 p.m. Mountain Time on the Thursday preceding the scheduled hearing date. This statement must be filed at the Division's Santa Fe office at the above-specified address and should include the names of the parties and their attorneys; a concise statement of the case; the names of all witnesses the party will call to testify at the hearing; the approximate time the party will need to present its case; and an identification of any procedural matters that need to be resolved prior to the hearing.
