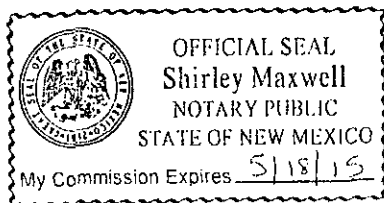

Division seeking an order,

standard oil spacing and
