STATEMENT OF THE CASE

APPLICANT

COG Operating LLC ("COG") seeks approval of a 160 acre non-standard spacing and proration unit in the Yeso formation (West Maljamar-Yeso Pool) comprised of the W/2W/2 of Section 15, Township 17 South, Range 32 East, N.M.P.M., and the pooling of all mineral interests in the Yeso formation.

OPPONENT

ConocoPhillips Company ("ConocoPhillips") is a working interest owner in the W/2W/2 of Section 15, and is the operator (under an existing operating agreement) of the W/2SW/4 of Section 15. ConocoPhillips requests:

- (1) That COG's application be denied, because (a) ConocoPhillips has had longstanding plans to develop the W/2SW/4 of Section 15 (as well as other acreage in Section 15) with vertical wells, (b) it is the operator and majority interest owner in the W/2SW/4 of Section 15, and should be permitted to develop that acreage with vertical wells, (c) the W/2SW/4 of Section 15 has better reservoir quality than the other acreage in COG's proposed well unit, and approval of COG's application will impair ConocoPhillips' correlative rights, and (d) developing Section 15 with vertical wells is prudent;
- (2) In the alternative, that if COG's application is granted, ConocoPhillips be named as operator of the well because it owns a greater working interest than COG; and
- (3) That even if COG's application is granted, ConocoPhillips be permitted to concurrently develop the W/2W/2 of Section 15 with vertical wells.




