STATEMENT OF THE CASE

WPX seeks an order (1) approving it's Northwest Lybrook Unit pursuant to 19.15.20.14 NMAC and (2) creating a new pool within the unitized area for horizontal development that will allow wells to be located anywhere within the proposed Unit so long as the completed interval is no closer than 330 feet from the outer boundary of the proposed Unit. The proposed unit area is comprised of approximately 2,002 acres of Federal, State and Allotted Indian lands situated in all or parts of the S/2 of Section 25, Sections 35 and 36 of Township 24 North, Range 8 West and

the E/2SW/4 of Section 30 and the N/2 of Section 31 of Township 24 North, Range 7 West, N.M.P.M., Rio Arriba and San Juan Counties, New Mexico. The unitized interval is from the top of the Mancos formation at a measured depth of 4,349 feet down to the stratigraphic equivalent of the top of the Greenhorn Limestone formation at a measured depth of 6,098 feet as encountered in the Federal 34-43 well in Section 34, Township 24 North, Range 8 West, N.M.P.M. (API No. 30-045-24521).
