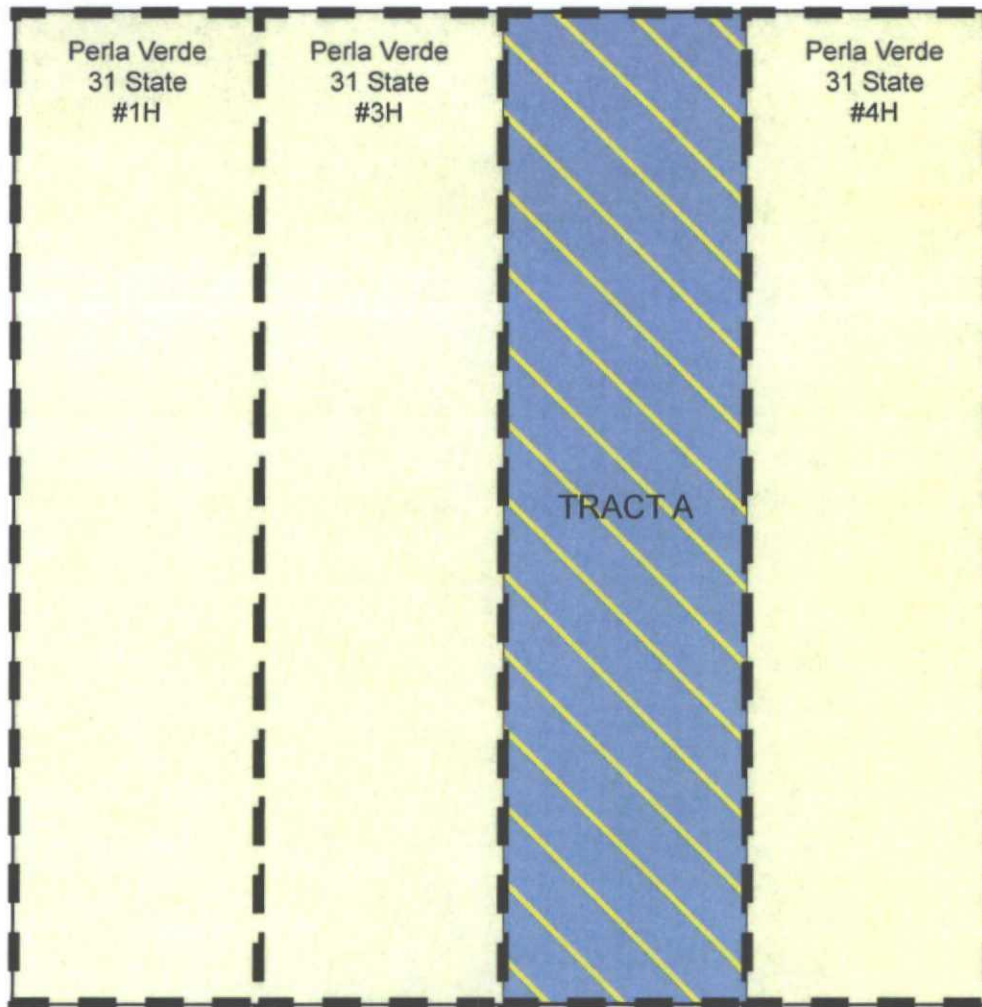

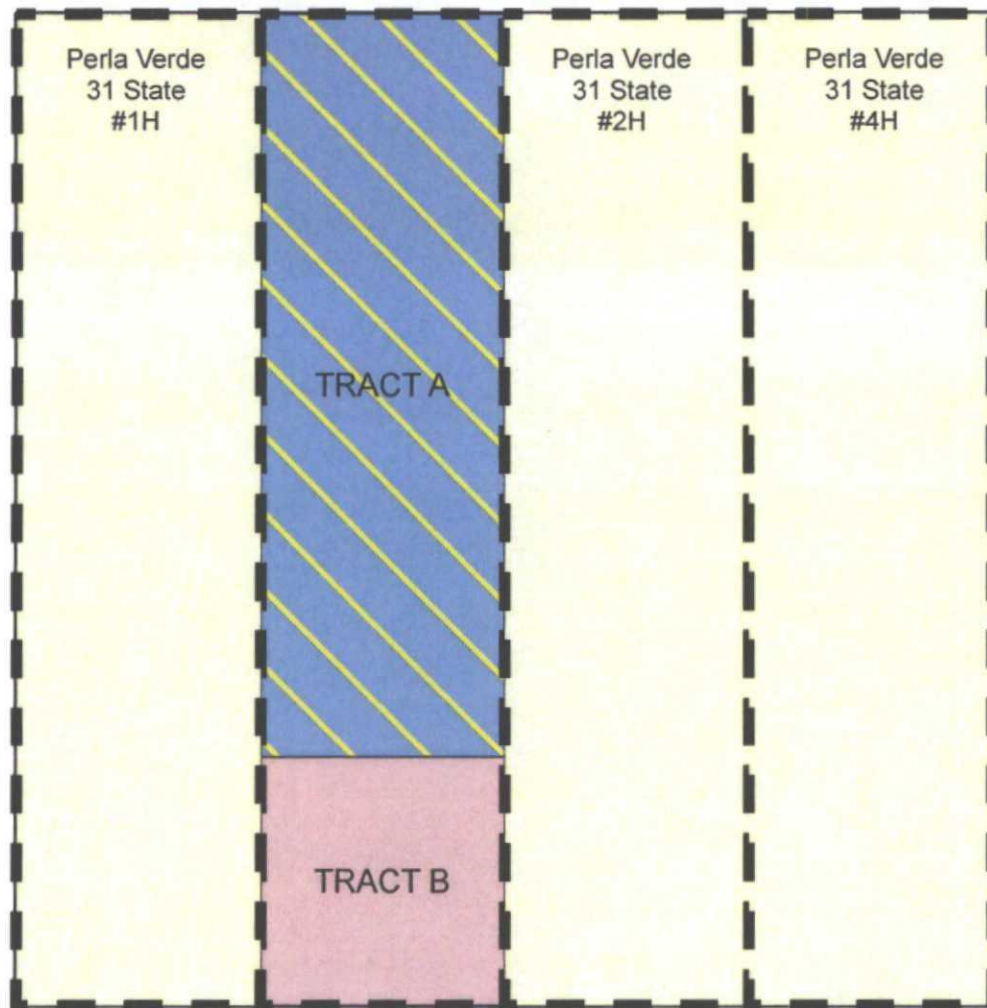
W/2E/2 of Section 31, Township 19 South, Range 35 East

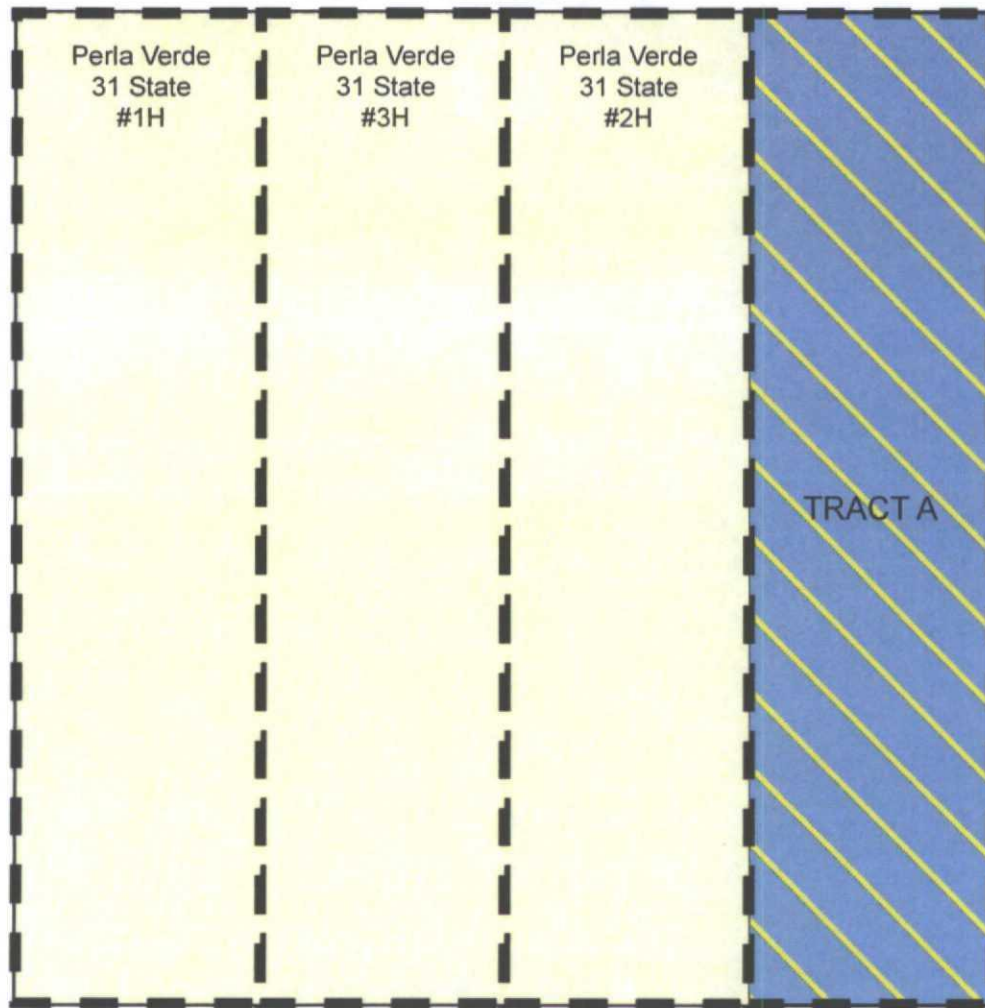
