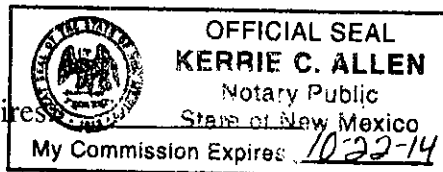


1. I am over the age of 18, and have personal knowledge of the matters stated herein.


Ladies and gentlemen:
